Land Protection. In 2013, the Land Trust completed 9 conservation projects conserving 424 acres of land, bringing the total land conserved by the organization to more than 9,100 acres. These projects include 7 new conservation easements conserving 368 acres of farmland, forests, and wetlands, and 1 new ownership of 14 acres and 1 addition to an existing ownership, conserving 56 acres. Protecting public drinking water is a top priority, and in Auburn, we worked with the Town of Auburn to acquire a conservation easement on 34 acres in the Lake Massabesic watershed. The lake is the water supply for Manchester and surrounding communities. In Hampton Falls, the Land Trust accepted the donation of a conservation easement on a 7 acre woodlot on Nason Road. This tract was originally owned by a founding member of the Rockingham Land Trust, Richard Niebling. With the family's donation of a conservation easement on 17 acres of woodlands and wetlands, the Land Trust completed the third and final component of the Batchelder Farm project. Easement Stewardship. Our easement stewardship program continued to uphold our commitment to perpetually steward the conservation easements we hold. In 2013 we again monitored 100% of our 115 conservation easements, as well as monitored or confirmed the monitoring of the 15 easements which we hold the executory interest on (back up to the primary easement holder). Our ability to effectively and efficiently monitor our growing portfolio of easements is made possible by our great network of 29 volunteers. Volunteers visited thirty-five of the properties while staff completed ground visits or aerial observations of the remaining properties. During our routine monitoring there were several minor on-going issues observed, often due to abutter activities, such as soil erosion caused by motorized vehicles, encroachment of lawn or dumping of brush. We also continue to strive to maintain and build on our relationship with landowners through our personal interactions, the biannual easement stewardship newsletter Everlasting, CONTINUED ON SCHEDULE O

4c (Code _____) (Expenses \$ 234,057 including grants of \$ _____) (Revenue \$ 189,148)

Land Management. Over the past five years, the amount of land owned by the Land Trust has grown dramatically to more than 2,600. In 2013, the Land Trust initiated the first of a two phase wetlands restoration project at the 530-acre Mast Road Natural Area in Epping. This work involved some first of a kind restoration of badly rutted and eroded ATV and 4x4 trails. Access was controlled by gates, fencing and guard rails. Volunteers helped remove hundreds of tires and tons of litter and trash. Deeply rutted trails were filled with sand from an old pit, and natural vegetation was replanted including button sedge, a plant found in only a handful of locations in the state. The old pit is now a vibrant field with an impressive catch of white clover and grass that will be managed for wildlife and recreation access is now on a long abandoned rail line. The second phase will be implemented in the summer of 2014. The Tucker & French Family Forest in Kingston and Danville was also the focus of considerable wetlands restoration work. Brentwood by accepting the donation of 42 acres on the Exeter River.

maintained trails were repaired, an illegally constructed earthen dam was removed, unauthorized trails were closed, several wildlife openings were created on the 13 acre French Mill pond, and volunteers helped remove tons of junk and debris. This work paved the way for significant trail upgrades in 2014 that will make the property more accessible to the general public and provide a great trail network for local snowmobilers. The Piscassic Greenway in Newfields also had a considerable number of upgrades. The parking area on Bald Hill Road was enlarged and an attractive stone wall was erected on one end making it easier to get in and out and allowing for more space. Split rail fencing was installed along the road, and one of the fields was tilled and reseeded. All of the trails were blazed and widened and considerable work was done on the interior woods road. Beyond these bigger projects, volunteers and staff helped with boundary and trail maintenance, property inspections, and trash removal on various other properties owned by the organization.
