THE MISSION OF UPPER VALLEY ROWING FOUNDATION (UVRF) IS TO CREATE A COMMUNITY FOR THE SPORT OF ROWING BY OFFERING A WIDE VARIETY OF OPPORTUNITIES FOR AREA RESIDENTS TO ROW ON THE CONNECTICUT RIVER BY MAKING AVAILABLE PUBLIC, ROWING-APPROPRIATE ACCESS TO THE CONNECTICUT RIVER, INSTRUCTIONAL PROGRAMS, COMPETITIVE OPPORTUNITIES, AND EDUCATION FORUMS ABOUT THE SPORT, UVRF WILL SERVE AS AN ORGANIZATION THAT PROVIDES DIVERSE BENEFITS TO THE REGION AS A WHOLE

28 IN 2013, THE UPPER VALLEY ROWING FOUNDATION HAD 176 MEMBERS, AND 18 COACHES AND ASSISTANT COACHES, AN INCREASE OF 37 MEMBERS. WE PROVIDED SCULLING AND SWEEP ROWING PROGRAMS FOR MEMBERS RANGING FROM HIGH SCHOOL FRESHMEN TO MEN AND WOMEN IN THEIR 70'S. IN THE SUMMER WE RAN LEARN-TO-SCULL INSTRUCTIONAL SESSIONS FOR 19 PEOPLE, AND LEARN-TO-SWEEP INSTRUCTIONAL SESSIONS FOR 18 PEOPLE. IN JUNE, WE HELD A FREE LEARN-TO-ROW DAY TO INTRODUCE COMMUNITY MEMBERS TO ROWING, DRAWING ABOUT 30 PARTICIPANTS. DESPITE NASTY WEATHER 2013 WAS OUR THIRD YEAR OFFERING A POPULAR 2-MONTH SPRING ROWING PROGRAM OPEN TO LEBANON AND OTHER AREA HIGH SCHOOLS (EXCLUDING HANOVER, WHICH HAS ITS OWN PROGRAM). 35 STUDENTS PARTICIPATED AND ARE RACING OTHER SCHOOLS IN THE REGION. WE TEACH BOTH SWEEP AND SCULLING TECHNIQUES TO THE JUNIORS, WHICH IS AN UNUSUAL FACET OF THIS PROGRAM. FOR HIGH SCHOOL MEMBERS, WE OFFERED FIVE ONE-WEEK SESSIONS IN THE SUMMER FOR BOTH NOVICES AND HIGH SCHOOL ROWERS WITH EXPERIENCE. 26 JUNIORS PARTICIPATED IN THOSE PROGRAMS. IN THE FALL, WE OFFERED A 6-WEEK RACE-ORIENTED PROGRAM FOR 19 HIGH SCHOOL STUDENTS FROM AROUND THE AREA.

REGIONALLY, WE RACED IN 7 REGATTAS INCLUDING THE HEAD OF THE CHARLES WITH PARTICIPANTS FROM AROUND THE WORLD. WE ALSO PROVIDE A SWEEP ROWING PROGRAM FOR ROWERS WHO DON'T WISH TO RACE FOR ANOTHER 18 ROWERS. WE HAVE 53 SCULLERS WHO OWN THEIR OWN BOATS, FOR WHICH WE PROVIDE RACK AND STORAGE SPACE.
