As noted on the Forms 990 filed for the last several years, certain events have taken place in the year 2013 to complete a tremendous ministry transition. The following comments are respectfully submitted to better describe those events and support certain entries recorded in this return.

SALE OF PROPERTIES

In accordance with a letter furnished the Internal Revenue Service dated June 23, 2012, and in line with a plan adopted by the Board of Trustees in 2011, the ministry sold three major parcels of real estate not used for ministry purposes. These properties were available for sale as a result of the closure of Beacon University a few years ago. Cottle Properties LLC purchased the parcels and the law firm Nicholson, Ray & Turner handled the closings. Due to the reluctance of Columbus Community Bank to lend all the monies needed for the closings, the ministry had to carry a smaller note until permanent financing can be obtained. No other financial institutions were willing to make the loan. Accordingly, terms, conditions, and interest rates of the secondary loan are identical to those in place with the bank loan.

When Beacon University was still operational, the annual financial statements were audited by a local CPA firm in Columbus, GA. During that span, the University obtained certain real estate to accommodate classroom and other needed space, including a library. These assets were obtained partially by gift of transfer and, to meet audit requirements, the parcels were appraised and placed on the books at the appraised values. Unfortunately, the appraisals took place right before the economic downturn creating what appears to be inflated cost numbers as future statements were prepared. When the university finally closed, REC Ministries took back the properties and maintained the same real estate values. Accordingly, for several years, the assets of REC Ministries have been shown at the higher and inflated values.

The real estate parcels were sold to Cottle Properties LLC on February 4, 2013 and the results are shown on Page 9, Part VIII, Line 7 of Form 990. To assure integrity and no conflict of interest, the purchased properties were appraised by two separate certified appraisers with the purchase price set at an average of the two appraised amounts. Consequently, when the loss on sale of properties was properly recorded, the net loss approximated 6.4 million dollars. This loss seems high; however, it is consistent with the inflated values of the real estate obtained from the closed university.

TRANSFER OF CLEN MINISTRY


Christian Life Educator's Network (CLEN) has been a tremendous school teaching students all over the world Christian principles and how to share the Gospel to a lost and dying world. On October 1, 2013, the entire ministry was gifted to a new organization headquartered in Spartanburg, SC. The new entity is called CLST Global and they have applied for tax-exempt status under Section 501(c)(3) of the Code.

Two major transfers took place on October 1. First, a large number of Master Courses presently taught by CLEN were donated to the new entity. On the day of the transfer, the book value of the Master Courses was \$432,780. Secondly, to help with initial expenses of the new entity, the ministry made a cash donation of \$100,000. Both of these amounts are shown on Line 1, Page 10, of Form 990 as "Grants and other assistance to organizations."

TRANSFER OF CHURCH IN MISSISSIPPI

Several years ago, a church in Meridian, MS was gifted to REC Ministries. Some time later, a new fellowship approached the ministry with the idea of purchasing the property on a lease to own basis. Twelve mortgage payments were received in 2013; however, the church disbanded late in the year and formally asked to be relieved of their financial obligations in exchange for signing over the property. The property will stay on the books of the ministry until a new purchaser can be found.
