The taxing authorities have the ability to assess taxes, penalties and interest for any years for which no tax return was filed. In the opinion of management, any liability resulting from taxing authorities imposing income taxes on the net taxable income from activities potentially deemed to be unrelated to the Credit Union's exempt purpose is not expected to have a material effect on the Credit Union's financial position or result of operations. The Credit Union evaluated its tax positions and determined no uncertain tax positions exist as of December 31, 2013 and 2012. The credit Union's 2010 through 2013 tax years are open for examination by federal and state taxing authorities.
