

Note 1- Accounting Policies

A summary of the significant accounting policies applied on a consistent basis by Boxford Trails Association/Boxford Open Land Trust, Inc. (the Organization) in the preparation of the accompanying financial statements is set forth below:

Nature of Business- the Organization was established to preserve and maintain trails in Boxford, MA for passive recreational use, and as a vehicle preserving open space through land acquisitions and grants in Boxford, MA. The Organization is a non-profit corporation and derives most of its revenue from direct public support.

Accounting Method- the Organization maintains its accounts in accordance with Statements of Financial Accounting Standards (SFAS) No. 117, Financial Statements of Not-for-Profit Organization to report information regarding its financial position and activities according to three classes of net assets: Unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

Use of Estimates- the preparation of financial statements in conformity with generally accepted accounting principles require the use of estimates and assumptions regarding certain types of assets, liabilities, revenue and expenses. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

Cash and Cash Equivalents- the Organization considers all highly liquid debt instruments purchased with an original maturity of three months or less to be cash equivalents.

The Organization maintains cash balances at various financial institutions. Accounts at bank are insured by the Federal Deposit Insurance Corporation up to \$100,000. The Organization's Accounts at these institutions may, at times, exceed the federally insured limits. The Organization has not experienced any losses in such accounts.

Investments- The Organization follows SFAS No. 124, Which states that securities should be stated at fair value.

Note 1- Accounting Policies (Cont'd)

Fixed Assets- All Fixed assets are stated at cost. Major additions and betterment are charged to the property accounts; while replacements, maintenance or repairs that do not improve or extend the life of the respective assets are expensed in the year incurred. Fully depreciated assets are retained in property and equipment until they are removed from service.

Income Taxes- The Organization is exempt from income taxes under Section 501 (c) (3) of the Internal Revenue Code.

Note 2- Operating Lease

The Organization leases its operating facilities as a tenant at will. For the year ended December 31, 2013, Lease expense totaled \$4,800.
