In 1985, P Leo Corcoran, a partner in the real estate firm John M Corcoran & Company, founded Caritas Communities, a nonprofit, nonsectarian organization Concerned about the rising number of homeless people, including working people unable to afford decent housing, Mr Corcoran and the original board of directors adopted the lodging house model as an efficient and affordable means of providing quality accomodations at an affordable rent From the beginning, Caritas has focused its efforts on preventing homelessness and stabilizing neighborhoods by providing affordable housing for people who can't make a living wage Starting with an 11 room property in Dorchester twenty-eight years ago, Caritas now owns 29 buildings throughout 14 Greater Boston communities with 892 rooms In 2013 Caritas completed the substantial renovation and preservation of the Connie Worcester House on Marlborough Street in Boston This 16-unit brownstone provides affordable housing for elderly, disabled and others on fixed income or who cannot make a living wage In 2013 Caritas, in partnership with the South Boston Neighborhood Development Corp, was awarded partial funding to re-purpose the former D Street police station in South Boston to become a 24-unit residential complex with preference for low and extremely low income veterans and families In 2013 Caritas received partial funding for the planned renovation of a 48 unit lodging house located on Cortes street in Boston's Bay Village neighborhood that Caritas acquired in December 2010
