

The Bureau received and evaluated 3,974 suspected insurance fraud referrals from the insurance industry, members of the public and other sources, of which 1,385 referrals were accepted for further investigation, resulting in 1,007 new investigative cases. After initial investigation, 699 cases were closed without criminal prosecution due to insufficient evidence of a crime

The Bureau referred 229 cases to federal, state and local prosecutors during the year, and supported those prosecutors in the location of witnesses, witness interviews, delivery of subpoenas and additional investigation. 185 individuals were initially charged with insurance fraud and other crimes during 2013, and court cases involving 184 individuals reached a final disposition.
