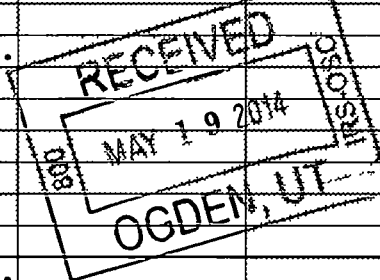

Second Amendment
to
The Josetta Fund
(Formerly Known As The Martha R. Gerry Townley Foundation)

Reference is made to the Declaration and Agreement of trust made June 13, 1995, by and between Martha R. Gerry Townley as Settlor and Martha R. Gerry Townley, F. Bradford Townley, and Mark A. Nowak as Trustees creating The Martha R. Gerry Townley Foundation, now to be known as The Josetta Fund, as that Declaration and Agreement was amended by a First Amendment dated March 18, 2008 (the "Trust").

ONE: The Trustees change the name of the Trust from "The Martha R. Gerry Townley Foundation" to "The Josetta Fund". All references to "The Martha R. Gerry Townley Foundation" shall be deleted and in each instance the phrase "The Josetta Fund" shall be substituted in their place.

TWO: Except as amended above, the provisions of the Trust are ratified and confirmed and shall remain in full force and effect.
