CECA, Inc. adopted new bylaws in 2013 in order to bring its governing documents into alignment with current practices and to insure compliance with state and federal expectations. The new bylaws provide more clarity in the expectations for members of the Board of Directors, more specificity in the handling of notification of and records of meetings, and better definition for reporting expectations.

Added to the bylaws are articles addressing conflict of interest and nondiscrimination. In essence, the bylaws were brought up to current standards for nonprofit organizations.
