This includes 4,875 children and 524 adults over 65 years of age. We provide emergency food to those in need in the New London area with a choice of foods to provide a balanced diet of fresh, frozen and canned foods. This includes vegetables, bread, fruit, peanut butter, dairy products, meats and various other products that become available to us.
