Overall expenses increased by \$66,638 (53%) due primarily to a major capital expenditure of approx. \$50,000 at our Fairfield Wards Field. There were no capital expenditures in 2012.

These expenses were categorized as field maintenance. As a result, net cash flow for the year was (\$39,788) in the red.
