Research Capacity Strengthening (RCS)

1. This program continued its fellowship program where the Center hosted xx postdoctoral fellows, xx pre doctoral interns and xx visiting scholars and 1 sabbatical fellow.

2. The program supported xx new doctoral students drawn from several universities in Africa under the African Doctoral Dissertation Research Fellowships. This brought the total number supported by the program to xx students since its commencement in 2008.

3. The Consortium for Advanced Research Training in Africa (CARTA), Which is an initiative involving 9 African universities, 4 Africa research institutes & selected northern partners now has xx doctoral students undergoing training. The program, was able to:

- continue with a model collaborative doctoral training program with strong supervision and mentoring components

- strengthen infrastructure, skills & faculty commitment to lead & manage research initiatives within the institutions

- contribute to the improvement of environments at African universities with the aim of facilitating and motivating researchers to stay and contribute to scholarly work within the region.

APHRC & the University of Witwatersrand, Johannesburg (South Africa) are jointly leading CARTA.

The Health Challenges and Systems (HCS) Research Program - This program is at the forefront of regional research to understand & prevent diseases that affect most people in sub-Saharan Africa. In 2012, the program:

1. CVD prevention & management in the slums (SCALE UP project) - The project successfully screened more than 6,000 adults for high blood pressure and diabetes in the two slum settlements in Nairobi. More than 450 of those screened and diagnosed with high blood pressure are obtaining high quality treatment and self-management care from an outreach clinic set up by the project.

2. Using Verbal Autopsy - the program successfully collected, analyzed & reported mortality data in order to describe the burden of disease profile in the informal settlements of Nairobi, Kenya. This process helped produce cause-of-death information that is being used to feed into national HIV/AIDS-related mortality estimates.

3. In partnership with Concern Worldwide, successfully collected & compared 5 rounds of data from slum & non-slum urban areas in Kenya in order to develop & empirically test indicators of urban emergencies suitable for triggering humanitarian response.

4. In partnership with the WHO, supported Ministry of Health in Mozambique to assess the country's health system performance in the past decade and inform the development of a new health policy framework.

Population Dynamics Program

1. Contributed to the understanding of practices of manliness among poor slum men in Kenya, the interaction of these practices with livelihood conditions, as well as the implications for poor men's relationships, health, & civic engagement of their gendered practice

2. Conducted "Meeting the Unmet Need for Family Planning & Improving Access to Safe Abortion Services (STEP UP)" project which seeks to improve access to family planning & safe abortions in Kenya, Ghana, Senegal, Bangladesh & India. The project is on-going.

3. Continued with evaluation of a set of interventions on improving the delivery and uptake of family planning in Western Kenya with the aim of reversing the stall of fertility decline in this particular region.

Impact: A noticeable expansion of community health workers' activities and a strong involvement of the Ministry of Public Health and Sanitation at the national, provincial and district levels.

4. Measurement, Learning and Evaluation (MLE) of the Urban Reproductive Health Initiative (URHI)

This program launched baseline survey reports for Kenya, Nigeria and Senegal to measure, learn from and evaluate the Urban Reproductive Health Initiative (URHI) providing reproductive health services in the three countries.
