

Working with this school, Team Tobati undertakes a large community service trip to Tobati, Paraguay every March. The team takes between 75 and 115 high school students to Paraguay to work on dozens of community service projects. The team builds classrooms, school bathrooms, parks, soccer fields, and other projects to help the poor community.
