What is the organization's primary exempt purpose?

Capstone's primary exempt purpose is to address the needs of some of Tijuana, Mexico's special-needs orphans, homeless, and working poor. Capstone employs 1) direct grant support of two orphanages located in Tijuana, that take-in among others, children that are difficult to place due to illness, disability, or a combination of the two, and 2) Capstone creates and facilitates a unique people-to-people partnership involving a network of Idaho volunteers who work to support grassroots leaders and service-providing organizations in and near Tijuana, through a series of projects constructing and/or improving physical facilities for individuals and charitable service-providing organizations. Several hundred volunteers over the past several years, including scores of college and high school students, have had unforgettable educational experiences working with and for Tijuana's poorest and most in-need, along with those who serve them. Corazon de Vida Foundation, St. Joseph's Home for ChildrenSupport of St. Joseph's Home for Children is the primary priority of Capstone Missions. St. Joseph's is an orphanage that opened approximately 20 years ago to care for children that neither the government nor any other orphanage would accept. These are children living with HIV/AIDS or other serious medical conditions, or other disabilities that make them difficult to place. Approximately 15 children reside at St. Joseph's Home for Children. The goal of St. Joseph's Home for Children is to provide the opportunity for stable & loving care, good schooling, tutoring, and successful medical interventions, to bring about transformations in these children's lives. During 2013, Capstone provided total direct grant support to St. Joseph's Home for Children in the amount of \$80,324. The grant support is administered by the Corazon de Vida Foundation, located in Irvine, California.


