BY-LAWS OF THE BARNES FOUNDATION, INC.

ARTICLE I - MEMBERSHIP

The members of the Corporation shall consist of the persons who have signed the Articles of Association of the Corporation and such persons as may from time to time be admitted to membership by a majority vote of the Members present at any annual or special meeting of the members at which there is a quorum present. Each Member shall continue to be a member until his membership shall terminate by death or resignation, but the membership of any Member may be terminated at any time, with or without cause and with or without notice, either at a meeting or by action in writing, by a majority of all of the other Members.

ARTICLE II - MEETINGS OF MEMBERS

Section 1. Annual Meeting. The annual meetings of the Members for the election of officers and directors and for the transaction of such business as may properly come before the meeting, shall be held in the month of January, in each year, upon the call of the President. Such annual meetings shall be general meetings and open for the transaction of any business within the powers of the Corporation.

Section 2. Special Meetings. Special meetings of the Members may be called at any time by the President and the President shall, upon the written request of three members, call a special meeting and cause legal notice thereof to be given. In case of the neglect or refusal of the President to call a meeting upon such request, such Members may call a meeting.

Section 3. Place of Meeting. Each meeting of the Members shall be held at the principal office of the Corporation in the City of Bristol or at such other place as shall be specified in the notice of such meeting, or waivers thereof.

Section 4. Notice of Meetings. Notice of all meetings of the Members shall be served upon each Member entitled to vote at such meeting at least five days before such meeting by mail, phone, email, text or any other means of communication decided on by the President or the Members. Such notice shall state the purpose or purposes for which the meeting is called and the day, hour and place of such meeting. No notice of the time, place or purposes of any meeting need be given to any Member who attends such meeting in person or by proxy, or to any Member who, in writing execute and filed with the records of the Corporation, either before or after the holding of such meeting, waives such notice.

Section 5. Voting. Every Member shall be entitled to one vote at each meeting of the Members of the Corporation. At all meetings of Members, each Member may vote in person or by proxy, but no proxy shall be valid after the expiration of eleven

months from the date of its execution unless the Members executing it shall have specified therein its duration. Every proxy must be executed by writing, emailing, texting, faxing, phone, electronic conferencing, by a duly authorized attorney or by any other means of communication agreed upon by the Members. No proxy need be dated, sealed, witnessed or acknowledged.

Section 6. Quorum. At all meetings of the Members of the Corporation, the presence, in person or by proxy, of one-third of the Members shall be necessary and sufficient to constitute a quorum, and, except as otherwise provided by law or by the By-laws, the act of the majority of the Members present shall be the act of the Members. In the absence of a quorum, the Members present in person or by proxy, by a majority vote and without notice other than by announcement at the meeting, may adjourn the meeting from time to time, for a period of not more than thirty days at any one time, until a quorum shall attend.

Section 7. Annual Report. At each annual meeting of the Members, the directors shall present a report, verified by the President and the Treasurer, or by a majority of the directors, showing the whole amount of real and personal property owned by the Corporation, where located and where and how invested, the amount and nature of property acquired during the year immediately preceding the date of the report and the manner of the acquisition; the amount applied, appropriated or expended during the year immediately preceding such date, and the purposes, objects or persons to or which such applications, appropriations or expenditures have been made; and the names and places of residence of the persons who have been admitted to membership in the Corporation during such year, which report shall be filed with the records of the Corporation and an abstract thereof entered in the minutes of the proceedings of the annual meeting.

ARTICLE III – BOARD OF DIRECTORS

Section 1. General Powers. The property, affairs and business of the Corporation shall be managed by the Board of Directors.

Section 2. Number, Term of Office, Qualifications, Method of Election. The Board of Directors of the Corporation shall consist of not less than three nor more than fifteen directors. Such number may be increased or diminished by amendment of these by-laws, but shall not be increased to more than fifteen nor diminished to less than three.

The initial directors of the Corporation shall be selected by, and from, those persons subscribing their names to the Articles of Association, and the directors, other than those so selected, shall be elected annually, at the annual meeting of the Members, and each director (whether elected at an annual meeting or to fill a vacancy or otherwise) shall hold office until his successor shall have been elected, or until his death or resignation or until he shall have been removed in the manner hereafter provided. In case of any increase in the number of directors, additional directors to

fill the vacancies in the Board of Directors caused by such increase shall be elected by the other directors. No director need be a Member of the Corporation.

At each annual meeting of the Members, the directors shall be chosen by a plurality of the votes cast.

Section 3. Meetings. An annual meeting of the Board of Directors of the Corporation shall be held in the month of January in each year, immediately following the adjournment of the annual meeting of the Members of the Corporation. Special meetings of the Board of Directors may be called at any time by the President or by any two directors. Each meeting of the Board of Directors shall be held at such place within the state of Connecticut as shall be specified in the notice of such meeting, or waivers thereof. Notice of every special meeting shall be given by mail, phone, email, text or any type of communication agreed upon by the directors at least two days before the day on which the meeting is to be held. No notice of the time, place, or purpose of any meeting of the Board of Directors need be given to any director who attends such meeting, or to any director who, in writing executed and filed with records of the Corporation, either before or after the holding of such meeting, waives such notice.

At all meetings of the Board of Directors the presence in person of one-third of the directors, but in no event less than three directors, shall be necessary and sufficient to constitute a quorum, and except as otherwise provided by law or the By-laws, the act of a majority of the directors present shall be the act of the Board of Directors. In the absence of a quorum the directors present, by a majority vote and without notice other than by announcement at the meeting, may adjourn the meeting from time to time, for a period of not more than thirty days at any one time, until a quorum shall attend.

Section 4. Vacancies. If any vacancy shall occur in the Board of Directors, the vacancy may be filled by the remaining directors, though less than a quorum.

Section 5. Removal of Directors. Any director may be removed at any time, with or without cause and with or without notice, either at a meeting or by action in writing, by a majority of all of the Members of the Corporation.

ARTICLE IV – EXECUTIVE COMMITTEE

Section 1. Powers of the Executive Committee. There may be an executive committee which shall have immediate charge, management and control of the activities and business of the Corporation, and, in the intervals between meetings of the Board of Directors, shall have and may exercise all powers of the Board of Directors in the management of the property, business, and affairs of the Corporation which are not specifically required by law or these by-laws to be exercised by the full Board.

Section 2. Designation of Members, Qualifications, Term of Office. The Members of the Corporation may designate from the Board of Directors an Executive Committee consisting of three directors. Thereafter, members of the Executive Committee shall be designated annually at the annual meeting of the Members. Each member of the Executive Committee (whether designated at an annual meeting of the Members or to fill a vacancy or otherwise) shall be and remain a director and shall hold office until his successor shall have been designated or until he shall cease to be a director or until his death or resignation or until he shall have been removed in the manner hereinafter provided.

Section 3. Meetings. The Executive Committee may hold meetings at such place or places within the state of Connecticut or at such other places as shall be specified in the notice of such meeting, or waivers thereof elsewhere and at such times as it shall determine from time to time. Notice of every meeting shall be by phone, mail, email, text or any other means of communication as agreed upon by the members of the Executive Committee at least two days before the day on which the meeting is to be held. No notice of the time, place or purpose of any meeting of the Executive Committee need be given to any member who attends such meeting, or to any member who, in writing executed and filed with the records of the Corporation, either before or after the holding of such meeting, waives such notice. The Executive Committee shall keep a record of its proceedings.

At all meetings of the Executive Committee the presence of persons and members constituting a majority of the membership of the whole Executive Committee shall be necessary and sufficient to constitute a quorum, and, except as otherwise provided by law or by the By-laws, the act of a majority of the members present shall be the act of the Executive Committee.

Section 4. Vacancies. If any vacancy should occur in the Executive Committee, the vacancy may be filled by the members at any annual or special meeting of the Board of Directors by resolution passed by a majority of the whole Board.

Section 5. Removal. Any member of the Executive Committee may be removed at any time, with or without cause and with or without notice by a vote of a majority of the Members of the Corporation at any annual or special meeting or by a vote of the majority of the Board of Directors then in office passed at any meeting of the Board of Directors.

ARTICLE V – OFFICERS

Section 1. Officers elected by Members. There shall be a President, one or more Vice Presidents, a Secretary and a Treasurer of the Corporation, all of whom shall be elected by the Members at the annual meeting for a term of one year or until their successors shall have been duly elected and qualified, except that the Board of Directors at its first meeting, shall elect officers to serve until their respective successors are elected at the first annual meeting of the Members and have

qualified. Any officer may be removed at any time, with or without cause and with or without notice, either at a meeting or by action in writing, by a majority of all the Members of the Corporation. A vacancy in any office by reason of death, resignation, removal, or any other cause may be filled by the Board of Directors at any meeting. The President shall be a director of the corporation, but no other officer need be a director of the Corporation and no officer need be a member of the Corporation. One person may hold any two of said offices except those of President and Vice President.

Section 2. Additional Officers. The Board of Directors at any regular or special meeting may by resolution appoint such additional officers, and such agents and employees, as it may deem advisable. All such additional officers, agents and employees shall hold office at the pleasure of the Board of Directors.

Section 3. President. The President shall exercise general supervision over the business of the Corporation, subject, however, to the control of the Board of Directors. He shall preside at all meetings of the Members and of the Board of Directors, and in general shall perform all duties incident to the office of President, and such other duties as from time to time may be assigned to him by the Board of Directors.

Section 4. Vice Presidents. The Vice Presidents shall perform such duties as are assigned to them from time to time by the Board of Directors or the President. At the request of the President, or in his absence or disability, the First Vice President shall perform all the duties of the President, and when so acting shall have all the powers of, and be subject to all the restrictions upon, the President.

Section 5. Secretary. The Secretary shall keep the minutes books and seal of the Corporation, record the minutes of the meetings of the Members and of the Board of Directors, and in general perform all duties incident to the office of Secretary, and such other duties as from time to time may be assigned to him by the Board of Directors or the President.

Section 6. Treasurer. The Treasurer shall have custody of all property of the Corporation, and from time to time, as requested by the Board of Directors or the President, shall render reports to the Board of Directors or the President, and in general shall perform all duties incident to the office of Treasurer, and such other duties as from time to time may be assigned to him by the Board of Directors or the President.

Section 7. Compensation. The elected officers shall serve without compensation, unless authorized by a concurrent vote of two-thirds of all the Members. The appointed officers, agents or employees shall receive such compensation, if any, as may be fixed by the Board of Directors or by the Executive Committee.

ARTICLE VI – EXECUTION OF INSTRUMENTS

All documents, instruments or writings of any nature shall be signed, executed sealed, verified, acknowledged and delivered by such officers, agents or employees of the Corporation, and in such manner, as from time to time may be determined by the Board of Directors.

ARTICLE VII – FISCAL YEAR

The fiscal year of the Corporation shall coincide with the calendar year.

ARTICLE VIII – PROHIBITIONS ON OFFICERS

No director or other officer of the Corporation shall (a) receive, directly or indirectly, and salary, compensation or emolument from the Corporation, either as such officer or director or in any capacity, unless authorized by the By-laws or by the concurring vote of two-thirds of all the Members, or (b) be interested, directly or indirectly, in any contract relating to the operations conducted by the Corporation, nor in any contract for furnishing supplies thereto, unless authorized by the By-laws or by the concurring vote of two-thirds of the directors.

ARTICLE IX – SEAL

The Corporate Seal shall be circular in form and shall bear the name of the Corporation and words and figures denoting its organization under the laws of the State of Connecticut and the year thereof, and otherwise shall be in such form as shall be approved from time to time by the Board of Directors.

ARTICLE X – CUSTODIAN

The directors may appoint a bank organized and existing under the laws of the State of Connecticut or the banking laws of the United States to act as Custodian of corporate assets, for such length of time as the directors may determine.

ARTICLE XI – AMENDMENTS

All By-laws of the Corporation shall be subject to alteration and repeal, and new By-laws may be made, either (a) by the affirmative vote of a majority of the Members of the Corporation entitled to vote given at any annual or special meeting, or (b) by the affirmative vote of at least a majority of the whole Board of Directors given at any meeting.

These By-laws were approved by an affirmative vote of a majority of the whole Board of Directors on May 18, 2013.
