The Foundation supports Norwalk Community College to further the development of the student body by providing funding for several programs The Foundation continued its support to fund four faculty positions for the Center for Science Health and Wellness for 3 years In accordance with Generally Accepted Accounting Principles the liability for the four faculty positions for 3 years was established in 2012 and the expense was accrued, but operationally the program is funded each year for 3 years The four faculty positions include a biology professor, a simulation laboratory specialist, an exercise science instructor, and a director in veterinary science The Foundation continues to support the Family Economic Security Program (FESP) which provides academic and financial coaching along with financial support to single parent students The Foundation also funded various college advancement initiatives
