The compensation for API employees is determined by the President and is formally evaluated annually. Salary levels are based on prevailing compensation skills by size of organization and experience. Objectives are set up each year, and performances are evaluated against those objectives. Salary increase and bonus are determined based on results of performance evaluations.
