NOTE 1: ORGANIZATION

The Riverbay Fund, Inc. (the "Fund"), a not-for-profit organization, was organized under the New York Not-for-Profit Corporation law. The purpose of the Fund is to promote recreational and cultural activities for the youth, senior citizens and other residents of ("Co-op City"), located in the Bronx, New York.

Revenues to pay for the Fund's activities are generated primarily from donations and fees charged at Fund-sponsored performances and events (ticket sales). Other revenues are received from sales of refreshments at events.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Fund's net assets and revenues, gains, and losses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, the net assets of the Fund and changes therein are classified and reported as follows:

- **Unrestricted net assets** – Net assets represents those resources that have no donor restrictions as to their use or the donor imposed restrictions have expired.
- **Temporarily restricted net assets** – Net assets subject to donor-imposed stipulations that will be met either by the actions of the Fund or the passage of time.
- **Permanently restricted net assets** – Net assets subject to donor-imposed stipulations that they be maintained intact in perpetuity by the Fund.

The Fund has no temporarily or permanently restricted net assets at December 31, 2013 and 2012.

Cash and Concentrations of Credit Risk

Financial instruments that potentially subject the Fund to concentrations of credit risk consist of a cash account held in a financial institution. At times, such accounts may be in excess of the Federal Deposit Insurance Company (FDIC) insurance limits. As scheduled, the unlimited insurance coverage for noninterest-bearing transaction accounts provided under the Dodd-Frank Wall Street Reform and Consumer Protection Act expired on December 31, 2012. Deposits held in non interest-bearing transaction accounts are now aggregated with any interest bearing deposits the company may hold in the same ownership category, and the combined total insured is up to at least \$250,000. As of December 31, 2013 and 2012, all of the Fund's cash was insured.

Contributions

Contributions, including unconditional promises to give, are recognized as revenue when the donor's commitment is received. All contributions are considered to be available for unrestricted use unless specifically restricted by the donor or there is an implied time restriction on the use of the assets. When a donor restriction expires, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statements of activities, as net assets released from restrictions.

Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Fixed Assets

Fixed assets are comprised of equipment, which are capitalized at cost and depreciated over their estimated useful lives (generally five years) on a straight-line basis.

Accounting for Uncertainty in Income Taxes

The Fund recognizes the effect of income tax positions only when they are more likely than not of being sustained. Management has determined that the Fund had no uncertain tax positions that would require financial statement recognition or disclosure. The Fund is no longer subject to audits by the applicable taxing jurisdictions for periods prior to December 31, 2010.

NOTE 3: RELATED PARTY TRANSACTIONS, DONATED SERVICES AND FACILITIES

Riverbay Corporation is an affiliated entity of the Fund and is a limited profit housing company, which was organized under the Private Housing Finance Law of the State of New York for the purpose of owning, maintaining and operating the low and middle-income cooperative housing development known as Co-op City. The Fund has the same Board of Directors and officers as Riverbay Corporation and receives a significant amount of administration support and use of facilities from the Riverbay Corporation. However, since no objective basis exists for recording and assigning value to these services, they are not reflected in the accompanying financial statements.

The Fund's insurance coverage is provided under Riverbay Corporation, Inc.'s policy. The portion of the Fund's premiums for 2013 and 2012 were \$1,325 and \$1,225, respectively.

On August 1, 2010, the Fund was awarded a \$1,000,000 grant from New York State Energy Research and Development Authority ("NYSERDA"), to be used for an energy efficient lighting program in the garages owned by Riverbay Corporation. In connection with the NYSERDA grant, the Fund entered a lease agreement as tenant with the Riverbay Corporation. The lease provides the Fund to possess, use, and access the roofs, exterior walls, power systems, utility risers, electrical and lighting fixtures and related fixtures and improvements of the Riverbay Corporation's eight garages. The lease provides for an annual rent of \$100,000 and expires on July 31, 2020. As of December 31, 2013, Riverbay Corporation made an in-kind contribution in the amount of \$100,000 in lieu of collecting rent owed by the Fund. Such amount is reflected as an in-kind contribution in the accompanying financial statements.
