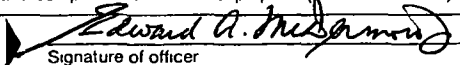

The Institute is exempt under IRC Section 501(c)(3) and is not a private foundation because it is a medical research organization, described in IRC Section 170(b)(1)(a)(iii), engaged in medical research into the causes and cure of cancer in conjunction with qualified hospitals. In 2013, the Fund provided grants and other assistance to the Institute in the amount of \$65,861,741 to support the Institute's medical research activities, including laboratory research and clinical trials
