In 2013, Room to Grow served 730 babies and their families, providing 6,200 hours of one-on-one parenting support and education with trained clinical social workers. The organization distributed over 100,000 new or nearly baby items, including developmentally appropriate toys, books, clothing, and equipment. Room to Grow engaged more than 4,500 volunteers to provide approximately 12,600 hours of service to organize and display donated items and assist with other organizational efforts. Room to Grow continues to maintain an excellent retention rate of over 88%, with nearly all families completing the program in years two and three. In addition, families report a significant increase in knowledge in core areas that are critical to the short and long term success and development of their children, such as early literacy, social-emotional development, nutrition, safety, and confidence in their approach to parenting. Families also show improved stability over the duration of the program through increased access to essential resources such as housing, social services, job training, adult education, and other important methods of stabilizing their family life and home environment. Room to Grow continues to promote awareness of the importance of early childhood interventions as the most effective and efficient way to break the cycle of poverty. Participation in conferences such as the Clinton Global Initiative (CGI) annual meeting and development of partnerships with other leaders in the early childhood space are a priority for the organization.
