The mission of Park Avenue Armory is to develop and produce unconventional works in the performing and visual arts that need non-traditional spaces for their full realization With its palatial period rooms by leading Gilded Age designers and its soaring 55,000 square foot Drill Hall, the Armory offers opportunities for artists to break the mold of traditional presentation, enabling them to create, and audiences to experience, epic, and adventurous work that cannot be done elsewhere in New York The Armory has also developed a unique creativity-based arts education program that uses its unique assets - a magical ruined palace setting and out-of-the-box arts program - to give underserved New York City public school students the tools to think creatively and to learn how to trust their own judgments

2013 was the first season fully programmed by Artistic Director Alex Poots, who was appointed in December 2011 With the resolve to increase opportunities for artists to realize their most expansive and free-wheeling dreams, Park Avenue Armory created a strong commissioning program and forged partnerships with similar cultural organizations worldwide in order to increase and enhance programming The season featured U S and New York premieres of performance works created by British theater artists Matt Charman and Josie Rourke, musical pioneers Massive Attack working with award-winning documentarian Adam Curtis, and theatrical visionary Robert Wilson working with performance artist Marina Abramovi? The Armory was home to the world premiere of a monumental visual and video art installation created by Paul McCarthy With the restoration and re-opening of the Board of Officers Room, the Armory inaugurated its first Recital Series featuring internationally acclaimed musicians performing chamber music in an environment as it was originally meant to be experienced For the second year, the Armory presented "Under Construction," a series of salon-style evenings presenting works in progress in the Armory's historic period rooms The 2013 season was attended by more than 64,500 audience members and covered widely by the press and social media Oktophonie The 2013 season opened in March with the New York premiere of Karlheinz Stockhausen's electronic musical masterpiece Oktophonie, a composition that requires an epic space like the Armory's Drill Hall for its full realization Oktophonie was performed by one of Stockhausen's original collaborators, Kathinka Pasveer Visual artist Rirkrit Tiravanija staged the work as the composer originally intended - in outer space - creating a lunar sitting surface, and asking the audience to don white cloaks that ritualized the experience 3,627 audience members attended this highly anticipated New York premiere, held March 20-27 The six planned concerts sold out almost immediately, and three more were added due to high demand Anthony Tommasini wrote in The New York Times that "The [drill] hall is becoming New York's site of choice for Stockhausen a chance to hear "oktophonie" in ideal conditions " Paul McCarthy's installation WS From June 19 through August 4, the Drill Hall was filled with the world premiere of WS, a monumental new visual and video art installation by Paul McCarthy One of the most influential and provocative voices in the international art world, McCarthy wove together a massive forest of towering trees with a video of social searing commentary on revered pop culture idols WS featured a massive forest filled with towering 30-foot tall trees and colorful, oversized flowers that extended across a raised landscape A ranch-style house replicating McCarthy's childhood home sat at the center of the fantastical forest and this 8,800-square foot sculpture and house-complete with open sets of a bedroom, kitchen, basement and hallways-served as the setting for the project's video performances The installation was littered with the detritus of the filming process, evidence of the performative nature of the work WS was the first visual art project presented under Artistic Director Alex Poots and curator Hans-Ulrich Obrist in association with Tom Eccles The installation appeared on several "Best of" lists for 2013, including those published in The New York Times and The New Yorker 29,409 people toured the installation, one of the most well-attended visual art commissions ever presented in the Drill Hall The Machine The fall season began with The Machine, a gripping new play written by award-winning British playwright Matt Charman and directed by Josie Rourke, Artistic Director of London's Donmar Warehouse The play was the first theatrical presentation that the Armory has co-commissioned for the Drill Hall Commissioning partners were Donmar Warehouse and Manchester International Festival, where the play made its world premiere in July 2013 Mr Charman's script depicted the dramatic 1997 battle of chess grandmaster Garry Kasparov against IBM computer Deep Blue and its wunderkind inventor Mr Charman explored the complex emotions of the human psyche through recent historic and technological developments, reflecting on the themes of evolution and destruction, and man versus machine Ms Rourke and the design team played on the idea of a gladiatorial contest, with the stage configured as a boxing ring and the audience seated on all 4 sides, peering down on the competition enacted by the cast of 23 The production played 16 performances for 7,623 audience members from September 4-18, 2013 Writing for Entertainment Weekly, Adam Horowitz described the production as "a theatrical machine, delightful in the complexity and precision of its actions " Massive Attack V Adam Curtis Music pioneers Massive Attack teamed with BAFTA Award-winning documentarian Adam Curtis to create an epic new multimedia installation for the Drill Hall, featuring original and live music and a new film The production was commissioned by Park Avenue Armory, Manchester International Festival, and Ruhrtriennale International Festival of the Arts Mr Curtis re-assembled video and music fragments from the past to try and make sense of the chaotic events of the present, and to "fuse a serious political argument with entertainment " Audiences experienced the film-described as a narrative documentary collage-projected onto 11 screens in a horseshoe configuration surrounding the audience Massive Attack, musical guests, and dancers performed behind the screens, which became translucent at key moments, throwing a spotlight on the live performances From September 27-October 4, Massive Attack V Adam Curtis played for six performances to multiple sell-out crowds, with a total of 9,952 audience members Ben Ratliff of The New York Times wrote, "The sound is a marvel, properly immersive, but not too loud or cavernous (United Visual Artists, the British art and design shop, is in charge of the installation and got it right ) If it has a further life as a film with music, screenable without the band's live performance, it could lodge in international culture as a perpetual undergraduate mind-blow " The Life and Death of Marina Abramovi? In December, the Armory welcomed visionary visual and theatrical artist Robert Wilson who re-staged his acclaimed, spectacular quasi-opera The Life and Death of Marina Abramovi? specifically for the Drill Hall The production featured performance artist Marina Abramovi?, Academy Award-nominated actor Willem Dafoe and singer Antony Hegarty At the intersection of theater, opera and visual art, the production saturated the audience with Wilson's stunning imagery in a manner not possible in a traditional theater The Life and Death of Marina Abramovi? reimagined the extraordinary life and work of Abramovi?, from her childhood in the former Yugoslavia to her present day work as a performance artist This eagerly-awaited New York premiere production was a once-in-a-generation cultural event that played to 10,700 audience members who attended the sold-out performances According to The Village Voice, The Life and Death of Marina Abramovi? was "[A] stunningly beautiful theater production - an expressive metaphysical pageant, reflecting on how an extraordinary life can defy death through art " Inaugural Recital Series Park Avenue Armory re-opened the historic Board of Officers Room in late September as a magnificent chamber music performance space The Board of Officers Room was designed by Herter Brothers, one of the most prominent interior design firms to America's Gilded Age families Working with architects Herzog & de Meuron, the Armory has restored the room to allow audiences to experience world-class music in an intimate salon setting as it was meant to be heard The 2013 Recital Series was launched with performances by internationally acclaimed artists who performed intimate concerts of chamber music Bartone Christian Gerhaher, accompanied by pianist Gerold Huber, opened the series on September 29 and October 1, performing a program of Schumann lieder Violin sensation Vilde Frang was accompanied by pianist Michail Lifits for a program of Mozart's sonatas during three performances held October 21-23 The series closed with three performances by pianist Anton Batagov on October 25, 26 and 27 Batagov performed Triadic Memories by experimental music pioneer Morton Feldman Nearly 1,100 audience members attended the inaugural recital series Artists in Residence and Under Construction Artists-in-residence and workshops find a natural home at the Armory, and create a collaboration that benefits the artists and the Armory The program gives artists space and inspiration to work on their projects They become part of the Armory community, and every day underscore the commitment to the out-of-the-
