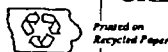

**IOWA NONPROFIT ARTICLES OF INCORPORATION  
OF

**TO THE SECRETARY OF STATE OF IOWA:**

The undersigned, acting as incorporator of the corporation under the Iowa Nonprofit Corporation Act, Chapter 504A of the Code of Iowa (2001) adopts the following Articles of Incorporation for such corporation:

**ARTICLE I - NAME**

The name of the corporation is PRESENTATION LANTERN. It is organized under Chapter 504A of the Code of Iowa (2001).

**ARTICLE II - OBJECTIVES**

Presentation Lantern, (hereinafter called the "Corporation") will conduct its activities to promote the purposes for which it was organized as set forth in the Articles of Incorporation. No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its trustees, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes and objects set forth in the Articles of Incorporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Bylaws, the Corporation shall not carry on any activities not permitted to be carried on:

- a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax law; or

- b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax law.

Additionally, the Corporation shall:

- 1) distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code;
- 2) not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code;
- 3) not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code;
- 4) not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code;
- 5) not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code.

### **ARTICLE III – CORPORATE EXISTENCE**

The corporation existence of this corporation shall begin on the date the Certification of Incorporation is issued by the Secretary of State of the State of Iowa and shall continue perpetually thereafter unless dissolved as provided by law.

#### ARTICLE IV – PURPOSE AND POWERS

The Corporation is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) for the Internal Revenue Code, as amended, including distributions to organizations that qualify as exempt under the Section 501(c)(3) and for the purpose of disseminating information and assistance to the general public, to provide hospitality, educational opportunities and advocacy to women and their children who are striving to better their lives; to assist them in gaining access to existing services; and to provide complementary services that develop their skills.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, except as otherwise may be permitted in Section 501(h) of the Internal Revenue Code of 1986, as amended.

Notwithstanding any other provisions of these Articles, the Corporation shall not conduct or carry on activities not to be conducted or carried on by any organization exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or by any organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, as amended.

As a means of accomplishing the foregoing purpose, the Corporation shall have all of the general powers set forth in Chapter 504A of the Code of Iowa (2001), and as it may hereafter be amended. These general powers shall be exercised exclusively for the attainment of the purposes of the Corporation as set for in this Article.

#### ARTICLE V – DISSOLUTION PROVISIONS

Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the remaining assets of the corporation to Dubuque Sisters of the Presentation providing sponsorship and support to this corporation, said assets to be used exclusively for the purpose of the corporation set to be used exclusively for the purposes of the corporation set forth in Article III hereof for assistance to women and children, or to such

organization or organizations operated exclusively as charitable organizations which would then qualify under the provisions of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, as the Board of Trustees shall determine. Any such assets not so disposed of shall be disposed of by the District Court of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said District Court shall determine which are organized exclusively for such designed purposes.

**ARTICLE - VI  
INITIAL REGISTERED AGENT AND REGISTERED OFFICE**

**ARTICLE VII - INITIAL BOARD OF TRUSTEES**

The number of trustees consisting the initial Board of Trustees of the Corporation is eleven (11).
