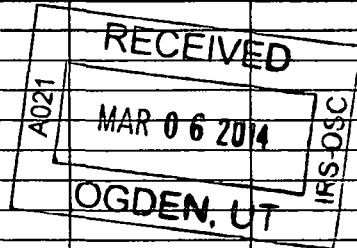

Sandy Murray Memorial Fund Project Review for Funds Allocated in 3013

This is probably the most exciting project report I've been able to send to you, the Board, of SMMF. Roger and I have just returned from visiting our project in Nicaragua and have witnessed just how creative and able our project director there has been.

A small group of nomads, Los Chorotegas, settled in Mozonte. They brought with them from Mexico the Náhuatl language that is still the basis of many village and family names in this rural mountainside community that sits near the Guatemalan border. In the 1500's the Spanish arrived with their culture, values and language. There were several small internal conflicts over the next centuries; however, it was the Nicaraguan Civil war and hurricane Mitch that created the current state of poverty and depression.

Of the 6,795 inhabitants of Monzonte, 1809 live in a small urban area, the remaining inhabitants are potters and farmers who sell their produce and pottery by the roadside, at ferias or in the weekly market in Ocotal. There is one high school and 15 primary schools and 1 Casa de Estudiantes funded by a family from Spain. That school allows girls to live and learn Monday through Thursday, receive three meals daily, including academic and emotional support. Currently one Peace Corp volunteer lives there as well.

Thirteen percent of the population is illiterate, and 44 % have not completed primary school. One point four percent have finished high school and .3% attends college. Osman recognized the weakest link for success there was the lack of education. He changed the focus of SMMF from providing 'grants or loans' to using money as a business education incentive. We now call his project the **SMMF Education Collective**. He had named it the **SMMF Comunidad Banco**. By providing small amounts of money to people who submit ideas for business improvement, and then requiring them to attend weekly class taught by himself, Peace Corp volunteers and his partner, a leadership instructor from a near by institute, he's not only improved their opportunities, he's encouraged the selected participants to return 100% of the learning incentive money within the class year.

Aside from C\$ 5,641.50 the total expenditure for education supplies, and one outstanding repayment of C\$ 6,800, the project has a balance of repaid money of C\$ 36,178.77. In US dollars that means that of the original \$2000.00 grant the project has and ending balance of (25.5 C\$=1.00 \$US) \$1,418.77 in the account. Four of the project participants have repaid their advances in the first year. The re-naming of the project as an education co-op rather than a community bank or foreign investment, also means we're not obligated to pay Nicaragua tax as a financial institution. Our money acts as education incentive and as tuition for business education.

I hope this adds to your understanding of how we are operating with locals, supporting locally focused ideas and creating sustainable of local projects. I'm thrilled that so little investment can do so much and provide a model for other small communities in the second poorest country in the western hemisphere.
