#### ***From the Environmental Working Group:***

Polluted runoff from farmland is having serious effects on Iowa's drinking water, but there is something you can do about it - today.

In November, state officials proposed a strategy for controlling pollution from crop fields, and they are now accepting public comments. Excess nitrogen and phosphorous flowing from agricultural land into Iowa's rivers and streams trigger dangerous algae blooms, endanger public health and contribute to the notorious "dead zone" in the Gulf of Mexico.

Unfortunately, the strategy proposed by the state falls far short of what Iowa needs to protect our water.

So far, very few Iowans have submitted comments. Adding your voice today will go a long way in making sure the state gets the message that we want a better strategy. It will only take a minute, so please act now.

#### **Suggested comments:**

- *While the state's proposed strategy recommends strict new rules for cities and industry, it falls far short in addressing agriculture's contributions to the excessive nutrients in our water.*

- History shows that relying on voluntary measures is ineffective. On average, only about 30 percent of Iowa farmers participate in voluntary programs, and 40 years of relying on this approach has done little to fix the problem.
- The strategy puts the bulk of the financial burden on taxpayers and expects them to contribute toward farmers' costs at all levels.
- Despite an accompanying science assessment that outlines the well-documented effectiveness of numerous conservation practices that farm businesses can implement immediately, the state plan recommends no minimum standard of care that farmers should follow.
- The state plan lays out no timelines, interim goals or means of measuring annual progress toward cutting agricultural pollution. Specifying milestones and expected results is a key element of any effective strategy.
- The strategy fails to specify how pollution control plans will be implemented, how problems will be prioritized or who will make these decisions.

## **Batavia CAFOs - Public Hearing Update, March 16, 2013**

## **Update on Batavia CAFO Public Hearing**

Approximately 60 people attended a Wapello County public meeting on Tuesday, March 12 to try to stop two CAFOs in that county from being built. Nick, Shawn and Jeff Adam of Valley View Swine are proposing two 4960-head CAFOs to be constructed just over the Jefferson County border. The CAFOs will significantly impact residents in the Batavia and Eldon communities as well as an important tourist destination, the American Gothic House.

Wapello County supervisors Jerry Parker, Steve Siegel and Greg Kenning read approximately 20 comments submitted prior to the meeting and an additional 20 people made comments at the meeting.

All comments, except for one, opposed the facility.

JFAN prepared a statement (see the attachment) that addressed seven problems with the CAFOs. These included issues with the manure application, the impacts on already problematic roads, and a history of the Adam family not adhering to Iowa laws with 42 violations uncovered by a Batavia resident.

Residents spoke on how the CAFOs would profoundly affect the lives of Batavia residents. Many people addressed problems they experienced with the Adam family over the years.

One of the CAFOs would be located less than 1875 feet, the minimum separation distance, from the Des Moines Baptist Primitive Church, which has been in Eldon since 1841. The pastor of the church spoke out against the CAFO.

Several JFAN members were present and made comments, as well as Iowa Citizens for Community Improvement. Both groups are working with the Batavia community to provide information and support to the neighbors.

Following the meeting, the Batavia group met to discuss further strategies. According to the lead organizer, they are determined to fight the CAFO, using all resources and means available to them.

The CAFOs are proposed for just southwest of Batavia, directly affecting approximately 20 families who live within two miles of the facilities as well as many other community members who live upwind of the proposed CAFOs. Site One, located only 200 feet away from the Jefferson County line, is scheduled to be built in May, and Site 2 will follow in August.

The confinements are planned at 4960 head, just under the 5000-head threshold that would require longer separation distances. The facilities are being located in Wapello County, as Wapello has not adopted the Master Matrix.

According to the lead organizer, Nick Adam reportedly told another member of the opposition group that the Adam family has long-range plans to expand to 80,000 hogs over the next few years. Shawn Adam was noncommittal about any expansion plan at the first community meeting held on March 1.

**Adam family 'would be wise to stop now'**

To the editor:

A host of Batavia and Eldon area residents have repeatedly asked Nick, Shawn and Jeff Adam to not build Valley View Swine because of the harmful impacts the 10,000-head CAFOs can have on their health, property values and quality of life. Yet the CAFOs are moving ahead. Shawn Adam was quoted in the April 26 *Fairfield Ledger* saying that he feels his family went "above and beyond their duties" by participating in a meeting and answering questions.

After being witness to and a participant in many of the meetings discussing the CAFOs, it's the opinion of Jefferson County Farmers & Neighbors, Inc. (JFAN) that the Adam family didn't go far enough to address the needs and concerns of the communities.

Apparently, that is also the opinion of over 70 neighbors who have sought legal counsel to help protect their health, quality of life and property values. They are currently working with local attorney and JFAN's legal counsel David Sykes who has teamed up with attorney Charlie Speer from Kansas City.

The Save Batavia and Eldon group has hope. Mr. Speer has a national reputation as the leading anti-factory farming attorney in the country. He has successfully protected many other communities like Batavia and Eldon and currently has cases in seven other states.

Of course, it would be ideal to stop CAFOs before they are built. But the nature of Iowa law makes it more conducive to start litigation once a CAFO is up and running and the damage they cause is more evident. This is an unfortunate disadvantage for both sides.

Mr. Speer has a reputation to secure very high monetary awards both in court and in private settlements. Mr. Sykes, too, has a successful history fighting CAFOs, working with JFAN since its founding and also as an independent legal counsel. It is promising and exciting to see Mr. Speer team up with Mr. Sykes in his first Iowa case.

Save Batavia and Eldon will not back down. And they shouldn't. To save a lot of unnecessary hassles for all involved, JFAN feels the Adam family would be wise to stop their CAFOs now and raise their hogs using traditional farming methods that don't create harm.

#### ***Great News! – KK Finishers Denied***

The Iowa Department of Natural Resources denied the second attempt of CAFO owner Ryan Robertson to expand KK Finishers, a 2480-head hog confinement. The proposed 1200-head expansion north of the city of Pleasant Plain would have swelled the confinement to 3680 hogs.

This denial was a big win for Jefferson County. JFAN worked very closely with the Jefferson County Board of Supervisors to review the Master Matrix. All the supervisors, including former supervisor Steve Burgmeier while still in office, did an outstanding job handling the review.

#### ***Although CAFOs Approved, Batavia and Eldon Residents Not Backing Down***

The DNR approved both Valley View Swine sites in mid April even though residents mounted a fight to oppose the CAFOs. Nearly 10,000 hogs will be located in two sites in Wapello County, just across the Jefferson County border.

JFAN has been working very closely with the group, attending meetings, evaluating the application and manure management plans, and discussing many facets of the application with the DNR. No Master Matrix was involved as Wapello County traditionally does not adopt this additional regulatory tool.

Site 1 is located within 1.5 miles of downtown Batavia, and Site 2 is approximately three miles of the city of Eldon and the American Gothic House. The Des Moines River Primitive Baptist Church, which has been meeting at the site of the current church since 1841, is only a third of a mile away from Site 2.

Even though both CAFOs are going up, Batavia and Eldon residents are not giving up. Nearly 70 plaintiffs have retained local lawyer and JFAN's legal counsel David E. Sykes to pursue legal action. Mr. Sykes has teamed up with Kansas City attorney Charlie Speer, who with his legal team of Peter Bieri of Kansas City and Richard Middleton of Savannah, Georgia, are reputed to be the nation's top CAFO-fighting lawyers, achieving numerous multi-million dollar awards on behalf of their clients. This legal team is taking the case on a contingency fee basis, which means the group will only have to pay for out of pocket expenses, dramatically reducing their costs.

JFAN has also given a \$5,000 financial assistance grant to the group to help with those additional costs.

#### ***Pork Shop – New Ryan Robertson CAFO***

On April 1, Ryan Robertson proposed another CAFO in Lockridge Township near the intersection of Germanville Road and 171st Street. The 2480-head hog confinement falls just 20 hogs short of the 2500 threshold requiring a Master Matrix.



JFAN notified over 30 area neighbors. The confinement is just 1300 feet away from a church used by the local Amish community.

One neighbor approached JFAN and discussed the possibility of opposing the CAFO. Together, JFAN and the neighbor evaluated the manure management plan to determine any weaknesses and to identify owners of the land on which manure will be applied. The neighbor was planning to petition the landowners to not accept the manure, sometimes an effective way to discourage a CAFO. We discovered that all the land parcels were connected with Robertson's family, and in the end, the neighbor decided not to pursue any further action.

The CAFO has since been approved. \*

#### **Hill Top Haven – Dale Robertson CAFO Undergoing Revisions**

Dale Robertson is revising his confinement operation, Hill Top Haven, and has applied for a permit to build a new 1500-head swine finishing building. Robertson currently has a 3550 finishing operation and a 2400-head nursery operation at the Penn Township facility.

The new configuration involves the removal of three older confinement buildings and the conversion of a nursery operation into a finishing confinement. In the end, the confinement will house 4105 head of swine finishers and no nursery hogs, bringing his overall head count lower than at present.

JFAN alerted neighbors within a two-mile area, including the residents of the city of Pleasant Plain. No one contacted JFAN to oppose the confinement change. \*

#### **From The Socially Responsible Agricultural Project**

Dear CAFO colleagues:

I just got word that the terrible Farm Bill Amendment #970 proposed by Grassley-Donnelly could go to a vote as soon as tomorrow. **The amendment would exempt factory farms from the Freedom of Information Act so that EPA would not be able to release any information about them to the public as it relates to any of their environmental regulations** (e.g., the Clean Water Act, Clean Air Act, CERCLA, EPCRA, etc.)

If passed, the law would have far reaching consequences for our work and would shield vital information that the public relies on to ensure our environment is protected from factory farm pollution. Just think about the implications if we were unable to obtain information about CAFOs under the Freedom of Information Act!!

Luckily Senator Ben Cardin (MD) has introduced a side-by-side amendment that will hopefully be voted on as an alternative to Senator Grassley's Amendment. It balances Freedom of Information to protect the public, but also respects information personal in nature.

### **Supervisors Fail New KK FInishers Master Matrix Application, June 10, 2013**

#### **Good News Again – KK Finishers Master Matrix Fails**

Immediately after we sent out our last email on KK Finishers, JFAN found out that Ryan Robertson again applied to expand his 2480-head hog confinement north of the city of Pleasant Plain by 1200 hogs.

Another Master Matrix was submitted, and JFAN analyzed the new application and manure management plan. As before, only 440 points were taken.

On Monday, June 3, the Jefferson County Supervisors met to score the Master Matrix. JFAN attended the scoring as well as a representative of Pinnacle Engineering, Mr. Robertson's engineering firm.

The supervisors did a thorough review of the application during a two-hour meeting and invited JFAN's comments throughout. JFAN found problems with seven of the questions. The supervisors agreed with JFAN on four and deducted 60 points. They failed the Master Matrix and will deny recommending the confinement to the Iowa DNR.

The DNR will make the final determination to approve or deny the facility, and JFAN will continue to follow up with the agency.

Once again, all the Jefferson County Supervisors did an excellent, detailed examination of the Master Matrix. JFAN is very appreciative of their openness to listen and seriously consider our comments.

##### **Confinement not up to Master Matrix**

Jefferson County Board of Supervisors spent nearly two hours Monday reviewing a third application and Master Matrix submitted by Ryan Robertson within 18 months to expand his hog confinement operation at KK Finisher site near Pleasant Plain.

The supervisors, two members of Jefferson County Farmers and Neighbors Inc. and John Everly, a manure management planner and soil sampling specialist from Pinnacle in Iowa Falls representing Robertson, went through the matrix that awards points for meeting various requirements to protect the environment and safety of the neighborhood at the confinement and any fields where manure will be spread.

A total of 880 points are possible; only 50 percent, or 440, are required to have the plan approved by the Iowa Department of Natural Resources.

DNR's website defines the matrix: "The Master Matrix is a scoring system that can be used to evaluate the siting of permitted confinement feeding operations. Producers in counties that have adopted the matrix must meet higher standards than other permitted facilities. Before they can be approved for construction, they must earn points on the Master Matrix for choosing sites and using practices that reduce adverse impacts on the environment and the community. Producers must have 50 percent — or 440 points minimum — of the total score and at least 25 percent of the available points in each of the three subcategories of air, water and community impacts to pass the Master Matrix."

Each of the three applications from Robertson has been submitted with only the minimum matrix points taken — 440.

"Why do this?" asked Supervisor Dick Reed who has been on the board for all three reviews the past 18 months. "Each time it's with just the minimum points. It seems like it takes a lot of money to play this game."

Jim Rubis of JFAN, said submitting the bare minimum "goes along with his [Robertson's] overall sloppiness.

"He's throwing this in over and over, hoping to wear you down," said Rubis.

Any disagreements in any category Robertson has credited points in his plan, can disqualify the matrix when submitting the minimum of 440 points.

Monday, the board of supervisors unanimously agreed the plan was short 60 points from among four categories:

- Robertson took 20 points for a landscaping plan to plant trees to mitigate odor around the confinement building. The plan showed the required three rows of trees on the north and east sides of the proposed new structure, that included a required mixture of fast and slow growing trees. In December 2012, the supervisors and JFAN questioned this same landscaping plan because it lacked details.

Everly pointed out this time, maintenance of the landscape was included.

"The plan shows three lines, it doesn't show spacing of trees," said JFAN director Diane Rosenberg. "A landscaping plan at the very basics should show placement of trees." Without placement or spacing specifications, the number of trees proposed is not known.

- Robertson took 30 points for a proposed "formed manure storage structure." The matrix specifies "covered or uncovered impoundment used to store manure from an animal feeding operation, which has walls and a floor constructed of concrete, concrete block, wood, steel, or similar materials. Similar materials may include, but are not limited to, plastic, rubber, fiberglass, or other synthetic materials.

Materials used in a formed manure storage structure shall have the structural integrity to withstand expected internal and external load pressures. The design, operation and maintenance plan for the formed manure storage structure must be in the construction permit application and made a condition in the approved construction permit.

"The design is the same as before [December 2012], and points were denied before by the DNR," said Rosenberg.

Everly said after the last submission, he talked with a DNR engineer.

"We did re-word the plan and added more details," said Everly. "The structure is a formed structure. We tried to demonstrate that in the latest document. It's a formed structure suitable enough to handle heavy equipment [tractors] around it.

"The engineer gave us some idea of why it was previously denied, but wouldn't give us verbiage," said Everly.

Rubis reiterated Rosenberg's contention that the design had no changes.

"The last DNR letter said the matrix was in conflict with design criteria and construction of the design submitted," said Rosenberg.

Supervisor chairman Lee Dimmitt said he would need the definition of what's in conflict.

"We feel it doesn't conflict," said Everly. "The engineer didn't explain it."

Supervisor Becky Schmitz, who was not on the board at the last Robertson matrix scoring in December, noted the supervisors allowed Robertson his points for the manure storage construction.

"DNR took the points away," she said.

- An emergency plan is required to be included in the construction plan, worth 5 points, which Robertson awarded his matrix.

The last time, the plan contained no specifics, said Rosenberg.

"Now, the plan includes more specifics, but no information about how to contain or clean manure spills," said Rosenberg.

Everly said this submission provided more details.

"My concerns are there's no implementation steps," said Schmitz.

The matrix requires a site map of the confinement building, and Everly said the plan includes the map.

"But it doesn't show the location of such things as propane tanks and electrical sources," said Rubis. "Part of the process of filling out the matrix is to make operators think about handling different situations."

- Robertson took credit for 5 points on his closure plan; i.e., if KK Finishers closed down operations.

Rosenberg said the last time, the county supervisors did not count any points for the submitted closure plan.

"And there's no difference this time," she said.

Everly said a paragraph with some details was included with the current submission.

"There's methods according to DNR we'll have to follow," said Everly.

Rubis said it was a generic closure plan.

"If you didn't get points on this last time, why take points now," asked Rubis. "The only thing that's changed is the DNR will be notified prior to closure. It's a good addition, but it's the only thing changed."

Dimmitt asked what the DNR was looking for in a closure plan.

"We allowed points for this before and the DNR denied them, and nothing's changed, what are they looking for?" said Dimmitt.

Everly said previously the DNR said the closure plan lacked details.

The supervisors and JFAN discussed a few other categories, but allowed the claimed points.

"My standpoint is, submitting with minimum points and we're disagreeing with the emergency and closure plans, and questioning the presences of old wells without documentation, and the landscape plan lacks details, I think this fails," said Schmitz.

Dimmitt said he also was concerned about the conflict mentioned by DNR about manure storage design and the lack of specifications in the landscape design.

"I don't know how we can say this plan is OK when we don't know what the conflict is," said Dimmitt.

Reed said his concerns included the landscaping and absence of wells claimed in the plan around the confinement and in the fields where manure would be applied.

"I don't know how anyone can tell where there were old wells without walking the land," said Reed.

Dimmitt said he would prepare the supervisors' report for DNR and Robertson with the deduction of 60 points.

- JFAN is also actively building relationships with organizations throughout the country to help strengthen our efforts here at home. Organizations like the Humane Society of the United States, Socially Responsible Agricultural Project, Pew Charitable Trusts, Watershed Media, and others.

As a result of these activities and many more, JFAN's presence continues to be a significant deterrent to CAFO growth in Jefferson County. **While other counties are experiencing expansion anywhere from 45-72%, JFAN held growth in Jefferson County to only 19%** according to the most recent USDA statistics comparing hog population between 2002 and 2010. In addition, all the new CAFOs in Jefferson County are in areas where there was no significant opposition from neighbors.

## **FOIA documents reveal Branstad interference is undermining prospects for badly needed Clean Water Act reforms**

### ***May 20 letter from Governor Branstad to Gina McCarthy, President Obama's pick to head the U.S. EPA, is a startling use of executive power on behalf of one of Iowa's most polluting industries***

Des Moines, Iowa – Governor Terry Branstad and Lt. Governor Kim Reynolds have intervened directly in high-stakes Clean Water Act negotiations between the Iowa Department of Natural Resources (DNR) and the U.S. Environmental Protection Agency (EPA), according to recently released documents obtained by a coalition of community and environmental groups – the Environmental Integrity Project, Iowa Citizens for Community Improvement (Iowa CCI), and the Iowa Sierra Club.

The groups say that the Freedom of Information Act (FOIA) documents clearly show that one of the Branstad Administration's top priorities is to shield a polluting industry from strong and effective public oversight by undermining what could be one of the most significant reforms in years to begin cracking down on factory farm pollution and cleaning up Iowa's 628 polluted rivers, lakes, and streams.

The most revealing document in the FOIA cache is a May 20th letter from the Office of the Iowa Governor to Acting EPA Administrator Bob Perciasepe and to Gina McCarthy, President Obama's nominee to be EPA Administrator. It was signed by both Branstad and Reynolds, and demands EPA officials come to Iowa for a tour with the Governor's office and the DNR, alongside corporate ag industry leaders.

"Governor Branstad's direct involvement in negotiations between EPA and Iowa DNR may be responsible for the delay finalizing a much-needed work plan agreement to fix Iowa's failing factory farm pollution program," said Tarah Heinzen, Attorney at Environmental Integrity Project and the writer of the coalition's FOIA request. "This letter demonstrates a troubling degree of political interference with Clean Water Act enforcement in Iowa."

Wally Taylor, attorney for the Iowa Sierra Club, said, "Branstad's letter to the EPA appears to be a brazen intervention directly on behalf of big agribusiness interests like the Iowa Farm Bureau Federation to the exclusion of everyday Iowans, consumers, and other community stakeholders." Iowa CCI members were even more blunt.

"I'm so mad I could spit," said Lori Nelson, CCI board president from Bayard, Iowa. "Governor Branstad, the Farm Bureau does not run this state. It's time to clean it up. Clean up our water, and clean up our government."

Branstad's May 20 letter specifically disputes EPA demands that Iowa factory farms large enough to require a manure management plan be inspected by DNR officials to ensure they are in compliance with the Clean Water Act. The letter also states that the Branstad Administration is opposed to EPA guidance over DNR procedures and training.

Branstad's letter rehashes standard corporate ag industry talking points while not once mentioning the water quality crisis in Iowa or the burden unregulated water pollution imposes on everyday Iowans across the state. Ratepayers in Central Iowa are currently spending \$7,000 a day since Des Moines Water Works turned on a \$3.6 million nitrate-removal system months ago after the public utility had run out of other options to deal with the pollution load coming down the Raccoon and Des Moines Rivers.

Branstad apparently went over the head of EPA Region 7 Administrator Karl Brooks by sending his May 20 letter directly to top decision-makers at the EPA's national headquarters in Washington D.C. The governor also carbon-copied his May 20 letter to Iowa's entire congressional delegation. The DNR was not carbon-copied in the letter, and it is not clear what extent DNR Director Chuck Gipp knows about the governor's involvement.

EPA Region 7 Administrator Karl Brooks was quick to respond to Iowa's governor. Brooks sent a reply dated May 31 to Branstad agreeing to meet with his office and industry leaders here in Iowa. However, another letter obtained by petitioners, sent from Brooks to DNR Director Gipp on March 20th, indicates that EPA's patience with Iowa decision-makers is running out and that further efforts to undermine the draft work plan agreement could jeopardize Iowa's authority to administer the Clean Water Act.

Another document in the FOIA cache is a redlined version of the EPA-DNR Work Plan Agreement, revised by the Iowa Farm Bureau Federation after a February meeting between industry groups and DNR staff. DNR sent the industry's revisions to the plan directly to EPA, but EPA's March draft rejected most of the Farm Bureau's attempts to water down the work plan.

The DNR and EPA have been negotiating this work plan agreement to bring the state of Iowa into compliance with the Clean Water Act after EPA released a scathing report on July 12, 2012 finding the DNR's factory farm enforcement program does not meet federal requirements. The July 12, 2012 EPA Report said DNR:

- Has failed to issue permits to factory farms when required,
- Does not have an adequate factory farm inspection program,
- Frequently fails to act in response to manure spills and other environmental violations,
- Does not assess adequate fines and penalties when violations occur.

The EPA report and subsequent federal action was forced by a 2007 de-delegation petition filed by the Environmental Integrity Project, Iowa CCI members, and Iowa Sierra Club and a 2011 Notice of Intent to sue the EPA for a failure to respond to the petitioners in a timely manner.

Iowa has more than 8,000 factory farms, 628 polluted waterways, and 800 documented manure spills, according to DNR records.

Breeding Bacteria on Factory Farms

**JULY 9, 2013**

The story of antibiotic-resistant bacteria in farm animals is not a simple one. But here's the pitch version: Yet another study has reinforced the idea that keeping animals in confinement and feeding them antibiotics prophylactically breeds varieties of bacteria that cause disease in humans, disease that may not readily be treated by antibiotics. Since some of these bacteria can be fatal, that's a scary combination.

Antibiotic-resistant bacteria are bad enough, but now there are more kinds; they're better at warding off attack by antibiotics; and they can be transferred to humans by increasingly varied methods. The situation is demonstrably dire.

Two of the examples highlighted in a Food and Drug Administration report are that about 10 percent of all chicken breasts sold at retail are contaminated with a form of salmonella that's resistant to at least one antibiotic, and nearly half of all chicken that's sold is contaminated with antibiotic-resistant campylobacter. Some of the antibiotics in question are used to treat sick people but are also used daily in raising livestock. And it seems that these livestock, especially ones raised by contemporary industrial means, are a breeding ground for making these and other bacteria more resistant [1] .

Some of this resistance comes from overuse in humans, but there's increasing evidence that resistance is being bred in animals that are a) raised in confinement and b) given antibiotics routinely. We want to know, of course, whether these bacteria move from animals to humans. Of particular concern is one called MRSA

ST398, or "livestock-associated MRSA." MRSA [2] is shorthand for Methicillin (a type of antibiotic)-resistant *Staphylococcus aureus*.

MRSA is serious [3]. Maryn McKenna [4], a journalist who specializes in these matters and the author of "Superbug," says that "MRSA is an underappreciated epidemic in the U.S. — over all, that organism causes more than 18,000 deaths and more than 365,000 hospitalizations a year — although we don't know how much of that epidemic 'livestock-associated MRSA' is responsible for."

The latest study concerning antibiotic resistance was published last week in the journal PLoS One. It looked at livestock workers in North Carolina (the nation's second biggest hog-producing state, after Iowa), including those in what the study's authors called "industrial" livestock production and those on farms where the animals were raised without antibiotics and grown on pasture. In this study, the *S. aureus* bacteria with genetic markers most closely linked to livestock were found in far greater numbers in workers on the industrial farms.

In fact, says Christopher Heaney, corresponding author of the study and assistant professor of environmental health sciences and epidemiology at the Johns Hopkins Bloomberg School of Public Health, "This study shows that these livestock-associated strains are present among workers at industrial livestock operations and that these strains are resistant not just to methicillin, but to multiple antibiotics — including antibiotics that are used to treat human infections."

Because the study looked at workers and not animals on the same farms, there are gaps to fill in, as Heaney freely admits. "But everyone in our study had direct or indirect contact with livestock," he says, "and one might expect to find similar prevalence of an opportunistic pathogen like *S. aureus* that is linked with livestock in both groups."

"But we didn't see that: we saw both a higher prevalence of drug resistance — for tetracycline and multidrug resistance — in the industrial compared to the antibiotic-free group and, in the industrial group only, we saw drug-resistant strains with multiple genetic characteristics linked to livestock."

"That's remarkable; we never expected to see something so clear at the outset of the study."

A reasonable person could assume that these drug-resistant staph bacteria are coming from animals, since you generally don't find them in the non-livestock-working population in the United States.

This is another dot in a sketch that's becoming clearer. There's evidence of MRSA moving from pigs to humans in Iowa -- where pioneering research has been done by Tara Smith at the University of Iowa — and in Europe, where Jan Kluytmans, an epidemiologist at VU University Medical Center Amsterdam, has found that "approximately 40 percent of all new persons with MRSA carry the livestock-associated strain, and most are related to contact with animals. Our data on MRSA are convincing that livestock is now a huge reservoir of MRSA for humans."

The F.D.A., which is under court order to do something about the routine use of antibiotics, has come up with a lame voluntary reduction scheme -- "Guidance 213," it's called — acting as if it will save its real regulatory muscle for after this scheme flops. (Which it will — flop, that is.) Worse, *despite repeated promises* that the voluntary guidelines were imminent, they haven't issued even those. And now, "Guidance 213 is currently in the clearance process, but we cannot predict a timeline on its release," an agency spokeswoman wrote me in an e-mail. Period.

That's simply insulting. Of course, almost no one is pushing the F.D.A. to do its job. There are a handful of people in Congress; certainly some well-meaning NGOs like Pew Charitable Trusts, Natural Resources Defense Council and others; and dedicated individuals like the lawyer Bill Marler. Against them are arrayed not only Big Pharma — which is providing four times as many antibiotics to animals as it is to humans — but industrial ag, which cares only about raising animals "efficiently" and profitably.

At whose cost? Well, the answer to that question, at least, is pretty simple.

Notes:

1. Bacteria can share resistance genes with other bacteria, even in humans, even with those that have never been exposed to antibiotics or seen the inside of a farm animal.

2. I said this was not simple: There are some broad categories of MRSA: community-associated, hospital-acquired (the best-known) and livestock-associated. Each of the first two comprises dozens — or more — different strains. At the moment, ST (sequence type) 398 is the most common livestock-associated MRSA, but there are others. And there is also MDRSA — for Multi-Drug Resistant staph aureus — which is ultimately even scarier, because the drug resistance has spread to other important antibiotics. (Like, "Oh, we can't use



methicillin? Let's use tetracycline. Oh, that doesn't work either?" Meanwhile the patient is getting sicker and sicker.) It gets more complex but no less awful.

**Top Three Questions Branstad Must Answer About Secret Clean Water Act Meeting  
EPA spokesman vaguely alludes to "various stakeholders" and "other state agencies" also attending a secret July 23 meeting in Des Moines, but public officials refuse to answer if corporate agribusiness lobbyists were also at the table**

Des Moines, Iowa – Iowa Citizens for Community Improvement (Iowa CCI) members have released a list of the top three questions Iowa Governor Terry Branstad should answer about a secret meeting that took place between the governor's office, the Iowa Department of Natural Resources (DNR), and U.S. Environmental Protection Agency (EPA) on July 23 in Des Moines.

Branstad's office, EPA Region 7, and the DNR have all independently confirmed their own involvement, but refuse to answer additional questions about who specifically was in the meeting from those offices and agencies, and if agribusiness interests also sat in on the meeting.

EPA Region 7 spokesman Kris Lancaster told the Associated Press that other "stakeholders" and "state agencies" were also present during the July 23 meeting, but declined to comment further. Lancaster responded to a request by Iowa CCI members for clarification by writing, "Please contact the hosts." Branstad spokesman Tim Albrecht and chief of staff Jeff Boeyink have not returned phone calls and emails by Iowa CCI members asking for comment.

● **Question #1** – Governor Branstad's office, the DNR, and the EPA have all independently confirmed their presence at a July 23 meeting in Des Moines. **Who specifically from each of those offices or agencies was present? Did Lt. Governor Kim Reynolds attend the meeting?**

● **Question #2** – EPA spokesman Kris Lancaster told the AP that other "stakeholders" and "state agencies" were also in the July 23 Clean Water Act meeting. **Who was he referring to? Was the Iowa Department of Agriculture (IDALS) present and, if so, who from that agency sat in on the meeting?**

● **Question #3** – In his May 20 letter to the EPA headquarters in Washington D.C., Governor Branstad requested a meeting in Iowa between his office, the DNR, the EPA, and "Iowa farmers, business owners, municipalities, and other stakeholders".

On May 31, EPA Region 7 Administrator Karl Brooks responded to Branstad's request by writing, "I respectfully suggest that those regulated parties with the most interest in Concentrated Animal Feeding Operation Clean Water Act permitting and evaluation should be invited to this conversation."

**Who were the "other stakeholders" and "regulated parties" present in the July 23 meeting? Was the Iowa Farm Bureau Federation present and, if so, who from that organization sat in on the meeting?**

The Iowa DNR and U.S. EPA have been negotiating a work plan agreement to bring the state of Iowa into compliance with the Clean Water Act after EPA released a scathing report on July 12, 2012 finding the DNR's factory farm enforcement program does not meet federal requirements.

The July 12, 2012 EPA Report said DNR:

- Has failed to issue permits to factory farms when required,
- Does not have an adequate factory farm inspection program,
- Frequently fails to act in response to manure spills and other environmental violations,
- Does not assess adequate fines and penalties when violations occur.

The EPA intervention was a response to a 2007 de-delegation petition filed by Iowa CCI members, the Environmental Integrity Project, and the Iowa Sierra Club. The petition called on EPA to strip the Iowa DNR of its regulatory authority under the Clean Water Act for its failure to enforce federal law against factory farm polluters.

Iowa's water quality crisis has never appeared worse than now, with 628 polluted bodies of water, and manure and other fertilizer runoff so high that Des Moines Water Works has kept the world's most expensive nitrate removal system running non-stop for months, costing 500,000 ratepayers \$7,000 per day.

Iowa CCI is a statewide people's action group that uses community organizing to build grassroots power and win public policy that puts communities before corporations and people before profits, politics, and polluters.

### **Some Good News - But Lots More Work to Do, August 11, 2013**

#### **Good News - KK Finishers - Denied!**

The Iowa Department of Natural Resources (DNR) denied the 1200-head expansion for KK Finishers, a hog confinement owned by Ryan Robertson north of the city of Pleasant Plain.

The Jefferson County Board of Supervisors reviewed and scored the Master Matrix application during a June 3 meeting. JFAN attended the meeting and recommended that 105 points be deducted from the application. The supervisors agreed with deducting 60 points. Since Robertson only took 440 points to begin with, the minimum for passing, the supervisors failed the Master Matrix and recommended that the DNR not approve the application.

After conducting their own independent review, the DNR deducted 100 points from the Master Matrix, bringing the final score down to 340 points. A DNR representative told JFAN that our detailed report contesting points

taken on several questions, coupled with the supervisors' comments, were useful in determining the final outcome.

This is Ryan Robertson's fourth attempt to expand KK Finishers. He has the option to appeal the application to the Environmental Protection Commission. JFAN will continue to monitor this CAFO.

### **CAFO Threatening West of Maharishi Vedic City**

JFAN has just learned that Jordan Morris of Fairfield is planning to build a 1240-head hog confinement on Fruitwood Avenue, south of 182nd Boulevard in Locust Grove Township. Mr. Morris appears to be working with Tri Oaks Foods, a large livestock corporation that would provide the hogs and feed for the CAFO.

The confinement is too small to be recorded by the DNR (it's 10 hogs short of requiring an application for a manure management plan). JFAN learned about the proposed facility from a neighbor who was approached by Nick Biggs, a public relations representative for Tri Oaks, informing residents in the neighborhood of the construction.

The planned CAFO is within 2 miles of the western border of Maharishi Vedic City. A letter was mailed to all neighbors within a two-mile radius on Saturday. Several neighbors, including representatives of Maharishi Vedic City, are quickly organizing to stop the CAFO and met with the Mr. Morris and Mr. Biggs on Thursday, August 8, to discuss their opposition. JFAN attended that meeting and is working closely with the group, providing informational guidance and support.

### **Two More CAFOs Threatening Jefferson County**

**Walnut Township:** A resident contacted JFAN on Monday to report that land purchased by David Eichelberger from farmer Curt Pacha will be used to build a CAFO. Eichelberger, the CAFO owner, also owns Eichelberger Farms, a large livestock company that supplies hogs and feed to other CAFO owners. Since no paperwork has yet been filed, the number of hogs at this CAFO is not currently known.

According to the neighbor, the CAFO will be located on Yew Avenue between 110th and 120th Street, near the Skunk River in Section 12 of Walnut Township. Other community members are also very concerned. The neighbor plans to organize a group to oppose the CAFO, and JFAN will meet with this group once it is formed. Letters will go out to residents within 2 miles of the CAFO informing them of the facility once we have more information.

**Penn Township:** The DNR informed JFAN on Monday that a CAFO is being proposed by Aaron and Matt Adams to be sited on Mahogany Avenue in Penn Township, approximately ½ mile south of 110th Street (Route H17) and approximately four miles due west of East Pleasant Plain. The facility is a wean-to-finish operation\* that will house 2480 hogs.

JFAN obtained the application and will be sending out letters to all neighbors within two miles of the CAFO. The Adam brothers are planning to apply manure to about one third of the city of Pleasant Plain and approximately one eighth of East Pleasant Plain.

### **DNR and EPA Sign Work Plan, September 17, 2013**

Dear JFAN Supporters,

We are happy to tell you that the Iowa DNR and the Environmental Protection Agency signed a Work Plan late last week. We are sharing information from the Iowa Citizens for Community Improvement website about the plan.

CCI has reported on the efforts of Governor Branstad and several corporate lobbying groups to weaken the work plan. But CCI, the Environmental Integrity Project, and the Iowa Sierra Club pushed back.

As part of that pushback, the three groups generated a letter signed on by over 20 organizations, including JFAN, to put pressure on the Governor and DNR. CCI attributes that letter to helping them leverage the best possible deal at a critical point in this fight, and JFAN is pleased to have contributed in some way.

There is more work to be done and much oversight by the three environmental organizations to ensure the state is in compliance, but this is an enormous step in getting Iowa's factory farms better regulated.

***From the Iowa Citizens for Community Improvement Website:***

**Environmental Protection Agency and the Iowa Department of Natural Resources have signed a far-reaching Clean Water Act work plan agreement that will significantly change the way the state of Iowa enforces, inspects, and permits factory farms.**

**You can read the final agreement and all related documents and materials on the EPA Region 7 website here.**

This is a huge victory for clean water in Iowa. The workplan mandates:

- on-site inspections for all large factory farms
- on-site inspections for medium-sized factory farms if they have had a sizeable spill in the last five years, or store manure in an open pit less than 1/4 mile from a water of the U.S.
- desk surveys for all other medium-sized factory farms
- increased separation distances
- tougher enforcement, including more violations subject to fines and penalties

The work plan process was initiated by the EPA in response to a 2007 de-delegation petition filed by Iowa Citizens for Community Improvement, the Environmental Integrity Project, and the Iowa Sierra Club. The petition called on EPA to strip the Iowa DNR of its regulatory authority under the Clean Water Act for its failure to enforce federal law against factory farm polluters. The petition will remain outstanding during the five-year implementation period.

Iowa Governor Branstad and industry groups pushed for a much weaker agreement that would have only guaranteed on-site inspections for about 500 of the very largest factory farms - those with more than 2,000 beef cattle or 5,000 hogs - but the final agreement requires inspections at at least 3,200 facilities after the petitioners and 17 other organizations demanded on-site inspections for all medium-sized and large factory farms.

The thousands of inspections and assessments DNR must conduct under the new agreement are intended to identify discharging facilities that require Clean Water Act permits.

**First Lawsuit of Speer/Middleton/Sykes Legal Team Filed**

The Save Batavia Eldon lawsuit is moving forward. On November 19, attorney David E. Sykes filed a petition in the Wapello County District Court on behalf of 70 plaintiffs of Save Batavia Eldon. The group is suing Valley

View Swine and two other CAFO operators for creating and maintaining a temporary nuisance that has impacted the plaintiffs.

The 26-page complaint names Nick, Shawn and Jeff Adam of Valley View Swine, as well as Larry Hickenbottom of Tri-L Farms, Josh Hickenbottom, and Richard Warren, all CAFO owners in the Batavia and Eldon area. In addition, the supplier/integrator for all the CAFOs, Cargill Pork, is named in the lawsuit.

There are approximately 20,000 plus hogs contained in the CAFOs, with 10,000 of them located at the two Valley View Swine locations.

This is the first lawsuit to be filed by the new Iowa legal team of Charlie Speer, Richard Middleton, and David Sykes. Thirteen other groups in seven Iowa counties representing approximately 500 to 600 plaintiffs are currently under consideration by the team. Sykes is also JFAN's legal counsel. JFAN provided extensive informational and organizational support to Save Batavia Eldon when Valley View Swine was proposed.

#### **Coalition Sues Van Buren CAFO; HSUS Names David Sykes Iowa Counsel**

A 7500-head sow operation run by Maschhoff Pork in Van Buren County that recently spilled thousands of gallons of manure into a Des Moines River tributary received a notice of intent to sue on November 21 by a coalition of community, environmental, and animal welfare organizations. Iowa Citizens for Community Improvement (CCI) represented by the Environmental Integrity Project and the Humane Society of the United States (HSUS), represented by attorney David E. Sykes, intend to file a lawsuit in the Iowa Federal District Court alleging violations of the federal Clean Water Act.

Sykes has recently been retained by HSUS as their legal counsel in Iowa to help file lawsuits against factory farms who have violated the federal Clean Water Act.

The Maschhoff CAFO experienced several spills in the past six years, yet the Iowa Department of Natural Resources did not require the confinement to obtain a Clean Water Act permit when the DNR inspected the facility in August.

Approximately 70 residents of Maharishi Vedic City and surrounding neighborhoods met last Wednesday, November 20 to address the Jordan Morris CAFO. Attorney David E. Sykes was invited to discuss their legal options.

A large community group, including over 100 individuals and corporate business entities, is organizing to take legal action against the confinement should nuisance issues become evident.

The confinement is nearly complete, and hogs are expected to fill the facility shortly.

JFAN has been providing significant informational support to neighbors opposing the CAFO.

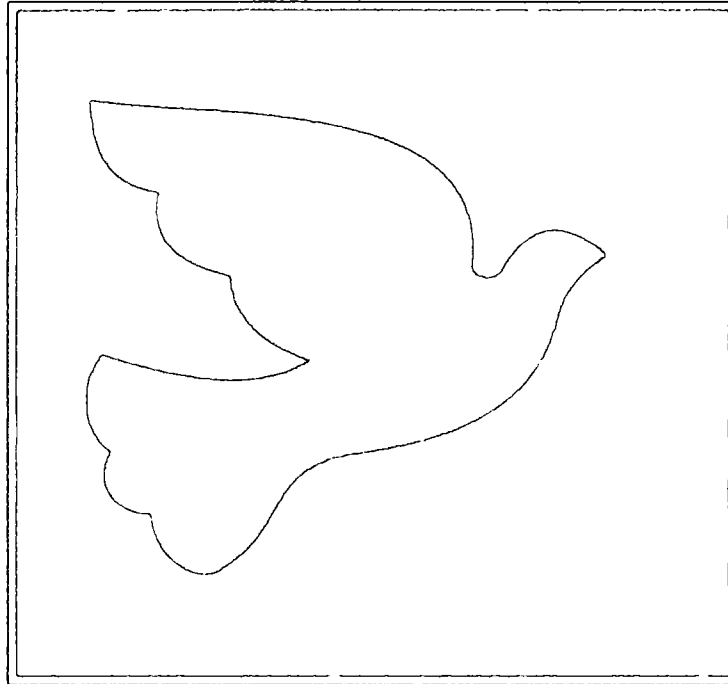
