The Wallkill Public Library has spent this money on new technology and internet services. In 2013, there were 3903 in-library computer/internet users and 72,384 visits to the library's website.

Program offerings, primarily children's programming, make up the 3rd largest portion of the program service expenses. In 2013, the Wallkill Public Library offered 662 adult, young adult, and children's programs. The total attendance for these programs was 11,611 people.
