NOTES TO THE FINANCIAL STATEMENTS

NOTE 1. ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Organization and Nature of Operations: The Buffalo Sabres Foundation (The Foundation) was incorporated in 1995 as a not-for-profit corporation. The Foundation is committed to enhancing the quality of life in the Western New York region by assisting youth hockey initiatives, supporting health and wellness initiatives, specifically those that serve the under privileged and handicapped, and providing support to non-profit organizations that provide vital services to those in need in our community. In that process, the Foundation strives to assist worthwhile organizations that make this region a better place to live and work.

Basis of Presentation: The financial statements have been prepared on the accrual basis of accounting.

Income Tax: The Foundation is exempt from federal, state and local income tax under Internal Revenue Code Section 501(c)(3) and has been classified by the Internal Revenue Service as an organization other than a private foundation.

US GAAP provides guidance on the financial statements recognition and measurement for income tax position that the Foundation has taken or expects to take in the Foundation's income tax returns. Organizations take many tax positions relative to tax laws, including those taken in determining whether tax is due, a refund is owed, a tax return needs to be filed, or the characterization of income as taxable (for example, unrelated business income) or nontaxable. The Foundation has not recorded any liabilities relating to uncertain tax positions.

The Foundation files its Return of Organization Exempt from Income Tax in the U.S. federal jurisdiction and its Annual Filing of Charitable Organizations in New York State. The tax years 2010-2013 generally remain open to examination in taxing jurisdictions in which the Foundation is subject to filing requirements of those jurisdictions.

Accounting for Contributions Received and Contributions Made: In accordance with United States Generally Accepted Accounting Principles (US GAAP), the Foundation recognizes contributions received as income and contributions made as expenses. The Foundation recognizes all contributions received, including unconditional promises to give, as income in the period received. All contributions are considered to be available for unrestricted use unless specifically restricted by the donor. Amounts received that are designated for future periods or restricted by the donor for specific purposes are reported as temporarily restricted or permanently restricted support that increases those net asset classes. When a temporary restriction is fulfilled, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restrictions. The Foundation recognizes contributions made as expenses in the period pledged or distributed.

Display of Net Assets by Class: The net assets of the Foundation are reported as unrestricted as there are no net assets which have been designated as restricted by outside parties.

Accounting Estimates: The process of preparing financial statements in conformity with accounting principles generally accepted in the United States of America requires the use of estimates and assumptions regarding certain types of assets, liabilities, revenues, and expenses. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, actual results may differ from estimated amounts.

Concentration of Credit Risk: Financial instruments that potentially subject the Foundation to concentration of credit risk consists of the cash account in a financial institution. Although the cash account exceeds the federally insured deposit amount, management does not anticipate nonperformance by the financial institution.

Accounts Receivable: The Foundation carries its account receivable at cost. On a periodic basis the Foundation evaluates its accounts receivable to determine any potential need for an allowance. No allowance has been deemed necessary by management for the year ended December 31, 2013 (\$32,000 – 2012).

Donated Goods and Services: In accordance with US GAAP, contributed specialized services are those services that would otherwise be required to be purchased had they not been contributed. The Foundation records all donated goods and services at fair market value.

NOTE 1. ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Subsequent Event: These financial statements have not been updated for subsequent events occurring after November 10, 2014, which is the date these financial statements were available to be issued.

NOTE 2. TRANSACTIONS WITH RELATED PARTY

Costs and revenue associated with fundraising for certain transactions of the Foundation are allocated from the sole corporate member. There was \$32,411 (\$177,415 – 2012) receivable from and \$884 (\$202,983 – 2012) of accounts payable due to this related party at December 31, 2013.

NOTE 3. COMMITMENTS

As of December 31, 2013, the Board of Directors authorized grants to not-for-profit organizations payable in future years in the amount of \$75,000 (\$75,000 – 2012). These grants are either payable at a definite time in the future as designated by the Board or are contingent upon future events, subject to compliance with various procedural requirements. All commitments remain subject to further review by the Board of Directors.
