28 Library Programs Staff Salaries The salaries are for the Library Director and 8 Assistant Librarians (all part-time) required for provision of services to Library Patrons, the maintenance and updating of the inventory of Library circulating items, planning of special programs, and all other operations of the Library. The Library is open 31 5 hours per week, 52 weeks per year. In 2013 the total number of patron visits to the library was 11,134. The library has 1251 registered resident borrowers and 229 non-resident registered borrowers. These figures do not include borrowers who are registered in other libraries but use the Poestenkill Library regularly for services. A Summer Reading Program, a weekly pre-school reading program, and other special programs for patrons are held throughout the year.

The total number of items in the Poestenkill Library collection at the end of 2013 was 35,299. This includes books, audio books, DVDs, music CDs, magazines, and electronic items. The total circulation for these items in 2013 was 20,589. There were 10,096 additions to Library holdings in 2013.

The regional library catalog access fee is the fee which is charged to each member library to provide and maintain that database for the year. This allows over one million items to be available to each patron in the Upper Hudson Library System and a courier system to deliver the materials from library to library. In 2013, a total of 3,883 items were borrowed by Poestenkill Library patrons through the Upper Hudson Interlibrary Loan System, and 6,950 loaned by the Poestenkill Library to other System libraries.
