TRUSTEE ACTION WINDING UP AND TERMINATING

WHEREAS, the undersigned as the Trustees of the Johnson Community Support Foundation (the "Foundation") have determined it to be consistent with the intent of the grantor and in the best interests of the Foundation to take the following actions pertaining to the winding up and termination of the Foundation; and

WHEREAS, pursuant to subparagraph 2(b) of the charitable trust agreement creating the Foundation, the Trustees shall distribute the remaining trust property upon termination of the Foundation to the Racine Community Foundation, of Racine, Wisconsin ("RCF"), for the exempt purposes described below.

NOW, THEREFORE, pursuant to the authority reserved to the Trustees of the Foundation under the charitable trust agreement creating the Foundation and applicable law, the Trustees hereby consent and agree to the following actions:

FIRST, effective immediately, the winding up of the Foundation's activities shall commence, and the Trustees shall satisfy from Foundation assets all outstanding debts and obligations of the Foundation prior to December 31, 2013.

SECOND, all remaining federal and state information returns, including the Foundation's final Form 990 and any filing required to be submitted to any state agency, shall be prepared and filed prior to December 31, 2013.



The Advisory Committee shall have sole discretion with respect to the distribution recommendations made to RCF. Subject to the Advisory Committee's discretion, it is anticipated that the Advisory Committee will recommend that future distributions from the Fund be made to one or more of the following charitable organizations: Mayo Clinic, The Prairie School, River Bend Nature Center, the Racine Art Museum, Next Generation Now!, the Wisconsin Humane Society Racine Campus, and the Experimental Aircraft Association (EAA) Chapter 838 Young Eagles.

However, the foregoing list of charitable organizations is not exhaustive. The Advisory Committee has discretion to select any one or more charitable organizations to receive distributions from the Fund.




