TO MEET ITS MISSION IN THE THREE CITIES WHERE IT OPERATES, THE GREENLIGHT FUND DOES THE FOLLOWING - RUNS AN ANNUAL PROCESS TO IDENTIFY CRITICAL COMMUNITY NEEDS, SEARCH THE COUNTRY TO FIND INNOVATIVE, RESULTS-ORIENTED NONPROFIT APPROACHES TO MEETING NEEDS, CONDUCT RIGOROUS DILIGENCE ON THESE NONPROFITS TO UNDERSTAND THEIR OUTCOMES, REVENUE MODEL, REPLICABILITY, AND POTENTIAL FIT ON THE LOCAL LANDSCAPE, AND SELECT ONE ORGANIZATION TO IMPORT INTO THE CITY THAT SHOWS THE GREATEST PROMISE OF MAKING A SIGNIFICANT, MEASURABLE IMPACT AS COST EFFECTIVELY AS POSSIBLE - SUPPORTS ORGANIZATIONS IT SELECTS WITH FINANCIAL AND NON-FINANCIAL ASSISTANCE GREENLIGHT PROVIDES AROUND \$600,000 OVER ORGANIZATIONS' FIRST FOUR YEARS IN THE NEW CITY, HELPS ATTRACT TALENTED LEADERSHIP TO THEIR LOCAL STAFF AND BOARDS, TAKES A SEAT ON THEIR LOCAL BOARDS, FACILITATES PARTNERSHIPS AND ADDITIONAL RESOURCES, AND SUPPORTS AND MONITORS PROGRESS TO BECOME SUSTAINABLE IN THE NEW LOCATION - LAUNCHES ORGANIZATIONS IN THE COMMUNITY BY SHOWCASING THEM AT EVENTS WHERE THEY CAN BUILD AWARENESS AND RECRUIT NEW SUPPORTERS SINCE ITS FOUNDING IN BOSTON IN 2004, THE GREENLIGHT FUND HAS IMPORTED NINE ORGANIZATIONS INTO BOSTON FRIENDS OF THE CHILDREN-BOSTON, RAISING A READER-MASSACHUSETTS, PEER HEALTH EXCHANGE, YOUTH VILLAGES' TRANSITIONAL LIVING PROGRAM, THE FAMILY INDEPENDENCE INITIATIVE, SINGLE STOP USA, THE NEW TEACHER CENTER, COLLEGE ADVISING CORPS AND BLUEPRINT SCHOOLS NETWORK SINCE 2012 WHEN IT WAS ESTABLISHED IN PHILADELPHIA, GREENLIGHT PHILADELPHIA HAS IMPORTED SINGLE STOP USA AND YEAR UP INTO THE CITY SINCE 2012 WHEN IT WAS FOUNDED IN THE SAN FRANCISCO BAY AREA, GREENLIGHT BAY AREA HAS SUPPORTED GENESYS WORKS AND UASPIRE INTO THE AREA IN 2013, THE NUMBER OF ORGANIZATIONS GREENLIGHT SUPPORTS ALMOST DOUBLED, FROM SEVEN JUST IN BOSTON TO 13 ACROSS THE THREE SITES THIS RAPID GROWTH WAS SPURRED IN LARGE PART BY GREENLIGHT'S RECEIVING A FIVE-YEAR, \$5 MILLION SOCIAL INNOVATION FUND AWARD FROM THE FEDERAL CORPORATION FOR NATIONAL AND COMMUNITY SERVICE NATIONALLY, ACROSS THE THREE LOCATIONS, GREENLIGHT-SUPPORTED ORGANIZATIONS ARE NOW REACHING 40,000 CHILDREN, YOUTH AND FAMILIES WITH THEIR INNOVATIVE PROGRAMS THAT ARE ACHIEVING MEASURABLE RESULTS IN THEIR EFFORTS TO TRANSFORM LIVES

THE GREENLIGHT FUND'S SOCIAL INNOVATION FUND (SIF) INITIATIVE AIMS TO ADDRESS THE ACHIEVEMENT AND OPPORTUNITY GAP FOR LOW-INCOME CHILDREN AND YOUTH IN THE THREE COMMUNITIES WHERE WE ARE LOCATED: BOSTON, PHILADELPHIA, AND THE SAN FRANCISCO BAY AREA. BY PARTNERING WITH SIX EXCEPTIONAL NONPROFIT ORGANIZATIONS, OUR GOAL IS TO CHANGE THE LIFE TRAJECTORIES OF CHILDREN AND YOUTH IN THESE COMMUNITIES WHO ARE TOO OFTEN OVERLOOKED AND LEFT BEHIND BY OUR EDUCATION SYSTEM AND ECONOMY. SELECTED THROUGH A COMPETITIVE PROCESS, GREENLIGHT'S SIF INITIATIVE PORTFOLIO ORGANIZATIONS DEMONSTRATE EVIDENCE OF IMPACT ON THE FOLLOWING OUTCOMES FOR LOW-INCOME CHILDREN AND YOUTH: 1. IMPROVED SCHOOL PERSISTENCE AND ACADEMIC ACHIEVEMENT; 2. INCREASED HIGH SCHOOL GRADUATION AND GED ATTAINMENT; 3. INCREASED COLLEGE ACCESS AND PERSISTENCE. GREENLIGHT'S SIF PORTFOLIO ORGANIZATIONS, OR SUBGRANTEES, ARE: SAN FRANCISCO BAY AREA - GENESYS WORKS - UASPIRE; BOSTON - BLUEPRINT SCHOOLS NETWORK - COLLEGE ADVISING CORP; PHILADELPHIA - SINGLE STOP - YEAR UP. GREENLIGHT'S SIF INITIATIVE HAS AWARDED EACH PORTFOLIO ORGANIZATION BETWEEN \$1 AND \$1.3 MILLION OVER FIVE YEARS TO SUPPORT THEIR EXPANSION INTO ONE OF OUR THREE LOCATIONS AND UNDERTAKE A RIGOROUS EVALUATION TO ADVANCE THEIR LEVEL OF EVIDENCE AND GROW THEIR IMPACT. GREENLIGHT'S SIF INITIATIVE HAS BEEN MADE POSSIBLE THROUGH A 2012 GRANT FROM THE FEDERAL SOCIAL INNOVATION FUND, ESTABLISHED IN APRIL 2009 BY THE EDWARD M. KENNEDY SERVE AMERICA ACT. THE SOCIAL INNOVATION FUND IS A COMPETITIVE GRANT PROGRAM HOUSED AT THE CORPORATION FOR NATIONAL AND COMMUNITY SERVICE.
