In addition to events the Advancement Office also solicits annual gifts throughout the year for our annual giving program, Gael Force, as well as, capital campaign - pledges specifically restricted to Bishop Gorman Development Corporation's projects. These solicitations are made through direct mail, e-blasts, personal phone calls and visits. A significant factor temporarily contributing to the decrease in the calculated percentage of public support has been the impact of large contributions by several donors who originally provided a significant portion of the capital campaign that enabled the high school's construction but have also recently committed substantial donations and pledges necessary to fund significant expansion of the school facilities. Upon receipt and reporting of these significant contributions, the calculation will revert to one evidencing broader public support.
