Lawrenceburg Main Street, Inc offers various business and city promotional programs and events to attract employers and consumers to the downtown Lawrenceburg area. Party in the Street has been a successful program to attract consumers from all over the Tri-state area to shop at local vendors.

4b (Code) (Expenses \$ **74,182** including grants of \$) (Revenue \$ **124,649**)

Lawrenceburg Main Street, Inc has an active improvement and beautification program that includes grant programs for commercial and residential facade paint and improvement, as well as, signs and awnings. Businesses are given 50% of the cost for paint/facade improvements up to \$1,000. Similarly, a business may receive 50% up to \$1,000 for signs and awnings. Residents may receive up to \$500 for exterior paint and improvements to their homes. In 2013 businesses were given 14 grants for exterior improvements, 8 grants were given for signs & awnings. Residences were given 22 grants. The total for these programs was \$28,196. A building improvement grant program for mixed use properties in the downtown area. A \$25,000 grant was available. 12 applications were received and 4 grants were funded.

Music on the River is Lawrenceburg Main Street's signature series. It included concerts every Thursday evening from mid June to mid September. The concerts were free and well attended. The concerts attracted people from Dearborn County and throughout southeast Indiana, as well as, neighboring Ohio and northern Kentucky. This series had built community spirit and pride and has raised public awareness of downtown Lawrenceburg.
