1. WAVE is a voluntary professional organization with the primary purpose to provide networking and mentoring for women in venture capital (VC) and private equity (PE), and for the women in professions that serve VC and PE, such as legal, accounting and executive recruiting.
2. WAVE held 15 events in 2013. These events were a combination of content and networking events and averaged 41 attendees per event. These events provide the opportunity for women to hear specialized, targeted information regarding the venture capital and private equity industry, as well as to meet and network with other women in the field.
