AFHA AmeriCorps program supports non-profit organizations and government entities in projects and activities centered on AFHA's themes of Conservation, Preservation, and Heritage Tourism Development. In 2013 45 National Service AmeriCorps Volunteers were deployed throughout the Appalachian Forest Heritage Area. In the field of ecology these members worked on projects ranging from invasive species eradication and education, stream surveys, tree planting, wildlife habitat restoration, and erosion control. In the field of Heritage Tourism our members assisted in museum development, site interpretation, adaptive reuse planning, archive development and documentation, and outreach. In Historic Preservation our members restored windows, repointed masonry, salvaged materials, and supported the adaptive reuse of historic structures.

Generally, AFHA AmeriCorps leverages additional volunteer capacity for its affiliated organizations by managing outreach and recruitment efforts, and adding capacity.

The AFHA Conservation Program supports interpretive trail design and implementation in strategic areas of the AFHA. The program also serves to educate the public on the dangers of non native invasive species and their role in the spread of such pests. In 2013 the USDA and AFHA partnered on both of these tasks utilizing grant money and other public support to fund the Slow The Onward Movement of Pests (S.T.O.M.P) program which educated the public on the dangers of moving firewood throughout the forests. Road signs, educational modules, PSAs, brochures, and flyers were dispersed strategically throughout the AFHA in support of these goals. Additionally, Interpretive Nature Trails were designed and updated in key areas of the forest to better service the public understanding and enjoyment of these areas.

AFHA Discovery Center - AFHA continued development of the AFHA Discovery Center to be housed in the historic Darden Mill. Set to open in the Spring of 2014, the Darden Mill will house interpretive exhibits for our organization, as well as the new WV RR Museum. The Darden Mill project has been an ongoing partner project of AFHA and is a testament to the value of our AFHA AmeriCorps program as it has played a major role in the redevelopment of the site.
