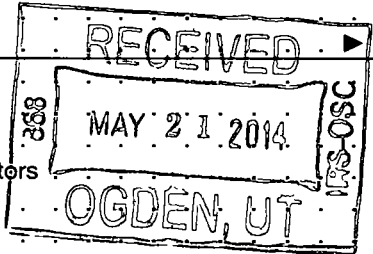



THE THREE EAGLE TRAIL FOUNDATION WAS ORGANIZED FOR THE PURPOSE OF CONSTRUCTING AND MAINTAINING NON-MOTORIZED TRANSPORTATION FACILITIES CONNECTING THE CITY OF EAGLE RIVER AND THE TOWN OF THREE LAKES IN NORTHERN WISCONSIN. THE PRIMARY COMPONENT OF THIS PROJECT IS THE THREE EAGLE TRAIL WHICH IS A CENTRAL COMPONENT OF A LARGER PLAN FOR TRAIL DEVELOPMENT BY BOTH ONEIDA AND VILAS COUNTIES AS ADOPTED BY THEIR COUNTY BOARDS IN COOPERATION WITH THE NORTH CENTRAL WISCONSIN REGIONAL PLANNING COMMISSION. THESE FACILITIES ARE OPEN TO THE PUBLIC FREE OF CHARGE ON A CONTINUING BASIS. THE MAJORITY OF THE FUNDING FOR THE ORIGINAL CONSTRUCTION WAS PROVIDED THROUGH GOVERNMENT GRANTS AND THE FACILITIES ARE NOW BEING EXPANDED AND MAINTAINED THROUGH CONTRIBUTIONS SOLICITED ON A CONTINUING BASIS FROM THE GENERAL PUBLIC, COMMUNITY ORGANIZATIONS, AND ADJACENT MUNICIPALITIES. THE ORGANIZATION COLLABORATES WITH BOTH THE TOWN OF THREE LAKES AND THE CITY OF EAGLE RIVER REGARDING ONGOING EXPANSION AND MAINTENANCE.

THE THREE EAGLE TRAIL FOUNDATION'S GOVERNING BODY IS COMPRISED OF ONE LOCAL ELECTED OFFICIAL AND SEVERAL CIVIC LEADERS. IN ADDITION TO PROVIDING FOR THE MAINTENANCE, OPERATION, AND IMPROVEMENTS OF THE PUBLIC FACILITIES MENTIONED ABOVE THE ORGANIZATION ALSO PROVIDES EDUCATION TO AND ADVOCACY ON BEHALF OF THE PUBLIC RELATED TO THE USE AND PROMOTION OF NON-MOTORIZED TRANSPORTATION OPTIONS IN THE EAGLE RIVER AND THREE LAKES AREAS.
