This included but was not limited to Souly Business, Cloud Walk Retreats, Ministry Ventures, Atlanta Insurance Prayer Breakfast, and Brookwood Church (Greenville SC), and Radical Mentoring Small Groups. Our Life Compass program served a total of 200+ men and women during the year. Our small group programs now include Life Compass, prayer groups, and spiritual mentoring. Community Prayer Times. We conducted monthly guided encouragement prayer times in 2013. During the year over 350 people experienced this group environment. Groups included individuals, families, small group, and leadership teams within organizations. Group Spiritual Facilitation.
