2. The Disappearing Corporation having no members or no members having voting rights, the Plan of Merger was duly approved by a majority vote of the Board of Directors of the Disappearing Corporation pursuant to RCW 24.03.195 on December 2, 2013.
3. The Surviving Corporation having no members or no members having voting rights, the Plan of Merger was duly approved by a majority vote of the Board of Directors of the Surviving Corporation pursuant to RCW 24.03.195 on December 4, 2013.
4. The merger shall be effective on December 31, 2013 at 11:59 p.m. Pacific Standard Time.
