Visiting pirate crews from up and down the eastern seaboard set up their encampments with period tents, performed skits, displayed their wares and performed demonstrations of their period artifacts. Live music is performed on stage in the park area. Over 50 crafters, food vendors and merchandise vendors set up tables to sell their wares, inflatable games are set up in center park area for children, as well as pony rides and a petting zoo. Ye Olde Beer Garden is set up in the pavilion.

Family Night Spaghetti Dinner held the 3rd Friday in September at the Community Center in Marcus Hook. This dinner precedes the Annual Pirate Festival and is prepared by the board members and served by the board members and volunteers. Those that attend can watch the visiting pirate crews set up their encampments while dining to live pirate music.

W3R Celebration and Free Ice Cream Social held the first Saturday in September which commemorates the Washington-Rochambeau National Historic Trail which goes through Marcus Hook whereby General Washington met the French troops at which time was the turning point of the Revolutionary War. Meet & greet at the historic Plank House with Borough officials and SAR Color Guard lead a procession of honored guests and visitors to St. Martin's Cemetery where those soldiers who fought in the Revolutionary War are honored. Following the memorial at the cemetery is a lecture at the Community Center given by historian, author and Neuman University Professor, Andrew Miller. Free ice cream social follows lecture.
