	One Vision International OVI is a non-profit that operates in order to meet the immediate physical needs of those who cannot provide for themselves. In 2013 we continued our work in Haiti and the Dominican Republic. We provided food, clothing, medication, shelter, and educational opportunities for 71 children living in the One Vision Childrens Home. We also provided educational opportunities through an after-school program in the Dominican Republic that serves over 150 children. OVI helped to provide them with school supplies, uniforms, and snacks. One Vision sent assistance by leading 16 trips to Haiti and the Dominican with over 200 trip participants traveling overseas. Trip participants helped more than just children by hosting medical clinics, dental clinics, and educational gatherings to teach trade skills such as sewing or carpentry to those in the communities of Haiti and the Dominican.
