

- Description of the project for which grant funds are being requested.
- Names of the organization's board of directors.
- Verification of the organization's tax-exempt status.
- A current financial statement.
- Cost of the proposed project and the amount being sought from the Foundation.
- Budget for the proposed project.
- Organization's budget.
- A list of other sources of support and the amounts and types of their donations.
- An explanation of whether this is an ongoing activity or a one-time project

Question 2d

The Foundation currently intends that its sole activity will be to make grants to other organizations which are exempt from taxation under Section 501(c)(3) in order to carry out the philanthropic objectives of Mutual of Omaha Insurance Company. The Foundation may also use its funds to engage directly in other 501(c)(3) exempt activities. The Foundation's mission is to prevent and break the cycle of poverty for families in the Omaha metropolitan area. The Foundation intends to focus its philanthropy in the Omaha community within the following areas:

- Preventing and ending homelessness through support of programs that focus on homeless prevention, emergency shelter and food.
- Encouraging self-sufficiency through support of programs that focus on literacy and language proficiency, workforce development, financial literacy and behavioral health.
- Providing education support through support of programs that address early childhood education and preparedness for graduation.
- Preventing and ending violence through support of programs that focus on youth violence and domestic abuse.
- Supporting projects that improve the community and provide enhanced quality of life.
