1. Puppets Ministry for Children: In prior years we sent volunteers from the USA to predominantly Muslim areas to teach local teams how to use puppets to teach children about God and His word. We also provided the materials that the local teams need for their ongoing puppet ministry. We are continuing to use that training and those tools to teach children.

In 2013 the cost of this ministry was \$8,101.

2. Church Planting. Endure International actively supports church planting efforts in a number of Middle Eastern and North African countries through local missionaries and staff. A good number of house churches and Bible study cell groups have been formed as a result of these efforts. In 2013 the cost of this ministry was \$20,135.

3. Bible Translation. In cooperation with other Christian ministries, Endure International has adopted a people group in a North African country and has actively supported and continues to regularly support the translation of the Bible into their indigenous language. The cost of this ministry in 2013 was \$12,283.

4. Orphanage Ministry. Endure International has assumed partial sponsorship of a worker at an orphanage in Morocco. The cost of this ministry in 2013 was \$11,377.

Each member discloses any possible conflicts so the board as a whole may be aware of them and determine how to deal with them. Each member signs the conflicts of interest policy annually.

Part VI, Line 15a The president's salary is set by the full Board of Directors (excluding the president and his wife), primarily based on comparisons with a large non profit organization in the same community.

The decision is made by the full board and is documented in the board's meeting minutes.
