IN 2013, THE SFE FOUNDATION SPONSORED ONE INTERNATIONAL DENTAL SERVICES TRIP TO NICARAGUA. THE WEEK-LONG EVENT WAS STAFFED BY A DOZEN VOLUNTEERS, INCLUDING DENTISTS AND SUPPORT STAFF.
