Creative Santa Fe (CrSF) is a nonprofit organization dedicated to strengthening Santa Fe, New Mexico's economy by cultivating thought leadership and by spearheading collaborative projects at the intersections of art, culture, technology, education, and industry.

Connect Santa Fe - CrSF is committed to city vibrancy, cultural partnerships, supporting Santa Fe's distinct creative and cultural assets, and supporting youth and nightlife. CrSF is also committed to fostering connections within Santa Fe's physical infrastructure of sidewalks, streets, bike routes, trails, and urban forest, as well as social networks that provide the engine that makes Santa Fe a rich community.

In 2013, CrSF hosted the FANTASE Festival as part of Connect Santa Fe. The FANTASE Festival was a community event involving lighting, projections, science, music, art, and interactive technologies. The event celebrated the opening of the newly redesigned DeVargas Park and

Education and outreach - "Create the Vote" was a CrSF driven collaboration of 35 arts, cultural, and creative organizations to raise the awareness of the impact of creative industries on the economy. Leading up to the March 2013 municipal elections, CrSF released questionnaires to all Santa Fe Mayoral and City Council candidates and hosted a mayoral forum. Other education and outreach activities included the CrSF website and a public lecture and discussion by expert Jeff Speck about why the future belongs to walkable cities.

4c (Code) (Expenses \$ 111,449. Including grants of \$) (Revenue \$)

Arts + Creativity Center (A + CC) - In partnership with the City of Santa Fe and others, in 2013 CrSF moved forward with the development of an affordable venue where creative individuals and artists of all disciplines can work, live, and launch their careers. CrSF successfully completed a community survey that will assist in the development of this Creativity Center. CrSF has moved into the pre-development phase of this project with City of Santa Fe and community support.
