Glory Reborn provides compassionate and holistic care to marginalized moms and babies of Cebu, Philippines In a tri-city area with a total population of nearly 2 million people, 46% of the population live on less than \$2 a day and nearly 15% of the population live on less than \$1 a day The average expectant mother receives no prenatal care, has almost never heard the heartbeat of her baby, and will rarely see an ultrasound of her baby during her pregnancy The combination of poverty and limited public health care creates an enormous problem for the people of the Philippines At the very heart of Glory Reborn is the Vision to build community Our primary focus is to build community and relationship with pregnant women In 2013,over 300 babies were delivered in our clinic And this year we passed the 3,000 baby mark We have a team of 34 staff, including volunteers, who help care for our moms and babies
