In 2013 WDC collaborated with over 35 conservation partners and worked in 6 states and 5 countries to collect species-specific information necessary for the preservation of wildlife and wild landscapes. Accomplishments include:

In Montana, first-ever dog surveys for the invasive plant, Dyer's woad, resulted in more than doubling the number of plants detected/removed.

In California, our work leveraged over \$2.5million for the purchase of permanently protected habitat for endangered San Joaquin kit fox.

In Zambia, dogs detected poacher's snares and set in motion a plan for placing permanently two dog teams in 2014 who will search vehicles to intercept ivory, bushmeat, and rhino horn being smuggled from the country. Two additional dogs will be found in animal shelters and added to our team to meet this need.

WDC continued to share the importance of conservation, and the detection dog methodology, by conducting 32 demonstrations and presentations for more than 2,400 from southern Africa to California. Additionally, we published 6 articles in technical and peer-reviewed publications, and were the subject of over 30 media pieces, reaching millions of people worldwide.
