SERVICES ENCOMPASS MEDICAL CONSULTATION, MEDICAL TESTS AND BIOPSIES, LABORATORY SERVICES, PRESCRIPTION MEDICATIONS, DENTAL SERVICES, HEALTH EDUCATION, AND REFERRALS TO DOCTORS OR HOSPITALS IN THE COMMUNITY. MANY SATURDAYS A CHAPLAIN IS AVAILABLE TO COUNSEL PATIENTS OF THE CLINIC. ALL SERVICES ARE FREE. PATIENTS MAY, BUT ARE NOT REQUIRED TO GIVE A DONATION.
