

4. EcstasyData - (expenses: \$14,132.28, grants: \$0, revenue: \$0)

Erowid Center runs a laboratory testing program that analyzes the contents of ecstasy, other street drugs, pharmaceuticals and novel psychoactive substances. Members of the public submit samples to a DEA-licensed laboratory. The purpose of the project is to collect, manage, review, and present laboratory testing results, including those from other organizations. The information is made publicly available to help harm-reduction efforts, medical personnel, researchers, and the general public. Results are published online at Erowid Center's Ecstasydata.org.

5. Conferences & Events- (expenses: \$13,355.71, grants: \$0, revenue: \$0)

Erowid Center conducts educational outreach in person with the general public at conferences, seminars, and festivals. In 2013, Erowid Center sent representatives to two major events, presenting public talks, workshops, and informational booths. This included the Psychedelic Science conference in Oakland, California (where a presentation and a harm reduction workshop were given), and the Horizons conference in New York City.

6. Experience Report Collection - (expenses: \$5,556.53, grants: \$0, revenue: \$0)

Erowid Center solicits, reviews, edits, and publishes first-hand reports of people's experiences with psychoactive plants, drugs, and technologies. This project produces vital information about psychoactive materials as well as aggregate data about why and how people use psychoactives, both for current factual documentation and for the historical record. All reports are reviewed and edited before being published. Trained volunteers perform much of the reviewing work.

7. Digital Document Archiving & Transcription - (expenses: \$4,241.76, grants: \$0, revenue: \$0)

Part of Erowid Center's mission is to collect, maintain, and preserve resources about psychoactives as a historical record for the future. In 2013, Erowid Center's primary digital document archiving projects were cataloging historical documents in the Stolaroff collection, and transcribing lab and chemistry notebooks from the Shulgin archives.

8. Data Collection through Visitor Surveys - (expenses: \$3,672.49, grants: \$0, revenue: \$0)

Erowid Center improves information about psychoactives and those who use them by conducting surveys of site visitors and other parties. Erowid's surveys gather data about health issues, use patterns, demographics, lifetime perspectives, and the spread of newly developed drugs. In 2013 we focused on surveying older adults through oral histories and targeted surveys, to record their views about their lifetime experiences with psychoactives.

9. Research Improvement - (expenses: \$2,363.49, grants: \$0, revenue: \$0)

Erowid Center improves scientific and sociological information about psychoactives and those who use them by promoting participation in studies produced by academics, educational institutions, and related organizations. We work directly with scientists—in areas where we have specialized knowledge—to help design credible studies and provide editing, reviewing, and fact-checking assistance for resulting academic articles.

10. Information Network - EEN - (expenses: \$780.41, grants: \$0, revenue: \$0)

Erowid Center has a moderated, reviewed network of both trained and self-taught experts with knowledge about psychoactive plants, chemicals, and technologies. Erowid Expert Network (EEN) members volunteer to share their expertise in order to help educate the public and improve the quality of information about this topic. The EEN facilitates making connections between those who are seeking information with experts who can help them. This furthers Erowid Center's mission by helping to improve both internal and external educational resources through increased fact-checking and review.
