FORM 990, PART III(2) NEW PROGRAM ACTIVITIES: In 2013 Green Cities Fund, in collaboration with the University of California at Berkeley, commenced the groundwork on a project to restore Cuba's longest river, The Cauto, whose headwaters commence in Berkeley, California's "Sister City" in eastern Cuba, Palma Soriano. The river, which is Palma's main public space, for swimming, washing and drinking, is polluted from the sewage flowing from Palma's 100,000 inhabitants. Using a low cost, low tech approach which can be emulated in other communities around the world, the sewage will flow into a series of ponds where the water will be cleaned by the sun and plants, flowing safely into community gardens. While basic research is being conducted, a proposal has been submitted to the United States Treasury to permit the project under existing regulations which allow U.S. organizations to engage in such humanitarian endeavors. A film on Palma and the project can be found at <https://vimeo.com/60928823>. Support totaled \$6,019 in 2013.

1) Earthseed Consulting (www.earthseedconsulting.com) provides professional advice to connect urban communities to the earth through permaculture and finding a better way to live on the planet in the urban environment. Support totaled \$15,000 in 2013.

2) Fondam Haiti is a non-profit organization in Haiti devoted to Haitian artists, who suffered especially after the devastating earthquake. Support totaled \$5,000 in 2013.

3) Karanee Burmese Refugee Project. At the end of 2004, thousands of ethnic minority refugees from Burma, who had spent their lives either as guerrillas fighting the corrupt military dictatorship in Burma, or as refugees fleeing the fighting, were admitted to the United States. Among them were small numbers of Karanee, who spoke neither English nor Karanee. Set adrift in inner cities with minimal assistance, they were often victims of crime and totally lost in their new society. Green Cities Fund established an ad hoc volunteer program to aid a community of approximately 100 of these refugees in Oakland, California. Urban farms were established, church groups were solicited to help, children were enrolled in school, adults were educated by retired school teachers and a myriad of other volunteer activities have been taking place over the past four years. Support totaled \$2,250 in 2013.

4) Barsky Fellowship Project. In 1966 Green Cities Fund president Tom Miller travelled to Vietnam with noted plastic and reconstructive surgeon Arthur Barsky, who had been chief surgeon of the Hiroshima Maidens Project. There they constructed and operated the Center for Plastic and Reconstructive Surgery to treat war-injured children. The hospital treated thousands of wounded children, including Kim Phuc, the little girl whose photo fleeing in terror from her napalmed village shocked the world. The hospital continues to this day, and is now a national center for plastic and reconstructive surgery. Tom Miller and Green Cities Fund has continued support for the hospital through fellowships, visiting surgeons and grants to enable disfigured poor children to have surgery. Support totaled \$2,500 in 2013.
