Lemonade Day is a national event that teaches kids the skills they need to be successful in the future. Youth learn to set goals, develop a plan, establish a budget, seek investors, provide customer service and give back to the community. Lemonade Day is the perfect opportunity for a community to show kids they care and train the next generation of entrepreneurs through a fun, engaging experiential experience. Lemonade Day is funded through sponsorships, donations and fees.

In 2013, P4L licensed the Lemonade Day program to 31 cities. Approximately 200,000 kids registered for the program.

In 2012, P4L offered the program in Houston and licensed it in 35 other cities. In January 2013, the Houston operations formed its own legal entity and became a licensed city of P4L.
