Baal Dan Charities ("Donation to Children" in Hindi) was formed to support the basic needs and social welfare of impoverished children (mostly orphans and street children) in Asia, Africa, North and South America. Given the vast number of impoverished children in these region, Baal Dan's grants were focused primarily on India from 2006 until 2012, and then on some additional pilot projects and grants in other countries in 2013 including Haiti, Pakistan, Ethiopia, Zambia and South Africa.

Baal Dan Charities focuses on identifying and vetting trustworthy organizations and partnerships in India that are child-focused and provide essential aid, shelter and education to vulnerable children, particularly orphans and street children. In 2013, Baal Dan audited these organizations for their impact, transparency and sustainability and provided specific grants for defined purposes such as food allocations, building projects (e.g. toilets, a water well etc.) and education (e.g. school fees, building education facilities, providing books etc). Since Baal Dan's inception in 2006, almost 200 projects have been reviewed and of those in 2013, 12 were selected as for grants and aid. These projects were then held responsible for reporting the impact and outcome of the Baal Dan grant that was provided and Baal Dan provided its donors with updates throughout the year through the e-newsletter and social media communications as well as an end of year report.

India: Providing education sponsorships, building a vocational training center, multi-year feeding programs and supplies, support and building maintenance and other grants for 9 orphanages/projects impacting almost 1,000 children.

Global Pilot Grants: From 2006 until 2012, Baal Dan has tested a highly effective model of providing aid to vulnerable children at grassroots projects in complex contexts. This model having been proven effective and efficient with relatively low administrative costs and a high degree of oversight was tested in some "pilot" countries in 2013. All the pilot grants provided were for very specific purposes as noted herein.

Pakistan: Provision of text books and supplies for an elementary school for 650 street children.

Haiti: Provision of food (eggs) for 42 orphans and the provision of a grant for a water well impacting the lives of 1,200 children and adults on a daily basis.

Zambia: Provision of a grant for toilets and nutrition for pre-school children in a remote area for 250 children.

South Africa: Provision of a grant to help renovate an orphanage (new toilets, kitchen area and supplies) for 30 children.

Ethiopia: Provision of education sponsorship for an impoverished child

Baal Dan raises money in the United States and then provides grants to projects in Asia, Africa, North and South America. Grants are allocated to orphanges, school, charities and grassroot projects that have been audited (personally visited) by a Baal Dan representative and meet certain requirements. Baal Dan works with these projects to determine how best to help the children in their care.

In order for a project to receive a grant application, certain requirements must be met. A grant application is required annually for each project. This application requires, among other things, a statement of the projects purpose and goals along with a brief description of sources of funds. The grant requestor agrees to use the funds provided by Baal Dan directly for the children it serves. It also agrees to provide written reports to Baal Dan as to the use of the funds as well as to maintain records and receipts for Baal Dan's review upon request. The projects selected for grants must allow unrestricted access to Baal Dan's representatives for purposes of project review, either through personal site visits, phone discussions or e-mails. Also, each grant requestor must certify that it has not provided and will not provide support or resources to any individual or organization that advocates, plans, sponsors, engages in, or has engaged in terrorist activity.

Once a grant request has been received, each request is reviewed and determined where the project is stable, reputable and in keeping with Baal Dan's purpose and goals. All grants over \$5,000 are approved by Baal Dan's Board of Directors. In most cases funds are wired to the grant recipient.

Baal Dan Charities was founded in 2006 as a US non profit 501c3 by Tanya Pinto. Board members were selected upon formation of the charity and re-elected on an annual basis. The Board meets via conference call quarterly at a minimum with the main Annual Board Meeting taking place in the first half of the year and occurring via conference call or with members residing in the same city present while others join by conference. Board Members vote on all grant distributions over \$5,000 and the Board is given the opportunity to view and approve all major distributions and expenses. To date, no Board members have ever been compensated. Two Board members are family relations with Tanya Pinto, the President. Each Board member represents a specific skill set and background which is critical to the success and vision of Baal Dan.

BARRACKPORE AVENUE SOCIETY: Baal Dan provided a grant of \$60,000 to cover multiple purposes. The grant monies included the construction of a vocational training center to benefit over 100 children and women in the area for a cost of \$15,000. It also included a multi-year allocation for the provision, maintenance, staffing, food and education expenses for 16 orphan girls at the Bachpan Girls Home and 14 orphan boys at the Bachpan Boys Home for the next 5 years. This grant was made to ensure security and sustainability for the children and also to create an effective exit strategy at the end of the multi-year period allowing time for the project to attract other donors.

LORETO SEALDAH: Since 2006, Baal Dan has provided grants to this project that helps almost 700 impoverished children with the provision of education and shelter. Baal Dan has sponsored 26 children from the slums since 2006, providing funding for their school fees, books, uniforms and medical needs. A grant of \$40,000 was made in 2013 to support these sponsored children for the next 3 years with their education expenses and at that time the children will be old enough to transition from elementary/middle school to high school.

CHILDLINE PRESERVE SHISHUR SEVAY: Baal Dan provided a grant of \$25,000 to provide 100% of the food cost for 14 orphans – most of whom have severe special needs. In addition the grant also provides specialized wheelchairs, educational tools, support for trained staff and other needs that arise for these vulnerable children.
