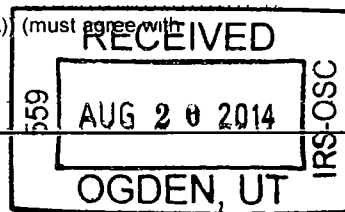

Supplemental Information

In 2011 the Ten Rivers Food Web was awarded a grant of \$300,000, to be paid in annual installments of \$100,000 from 2011 through 2013. This grant was mistakenly reported on the 2011 990-EZ on the cash basis, although the organization has elected to report on the accrual basis. That is, only \$100,000 of the \$300,000 total grant was included in revenue in 2011.

If the full amount of the grant had been reported on the accrual basis in 2011, it would have been reported on Schedule A as an unusual grant, since it is such a large grant in comparison to all the other funding the organization has received to date.

Since an unusual grant would not have been reported on Schedule A, Part II, Section A, Line 1(e) in 2011, the amount in 1(d) for 2012 has been changed from \$132,905 to \$32,905. This removes the \$100,000 that was originally reported, restoring Schedule A to being reported on the accrual basis, without the unusual grant of \$300,000.

In 2013, Ten Rivers Food Web continued its food literacy, food access and farmer development work across Linn, Benton and Lincoln counties. The organization had many staff changes throughout the year. Katy Alexander joined the staff as outreach coordinator and Kellianne Lauer served as TRFW's AmeriCorps VISTA volunteer. During the year community organizers Rebecka Weinstein, Chloe Rico and Kate Dolkas left TRFW to pursue new opportunities.

TRFW's food literacy work included a film series in Newport and Cooking Matters classes throughout Lincoln County. TRFW also coordinated the 4th annual Chef's Show-Off in Albany, a food preservation fair in Lebanon, and worked with many partner organizations to host a Food Day event in Corvallis. Many of these food literacy projects were made possible through support from localized community groups in Lebanon, Albany and Newport that TRFW had facilitated throughout 2013.

TRFW's food access work is centered on its That's My Farmer programming. In the summer of 2013, TRFW launched Oregon's first fresh fruit and

vegetable prescription program in Albany. In addition we held two farmers' market tours in Newport and Lebanon and coordinated many fundraising events to support the Corvallis-Albany Farmer's Market SNAP incentive program. Among others, these efforts included fundraiser dinners and an online donation campaign. In total, efforts raised over \$12,000 for incentives. SNAP incentives are now offered at 10 farmers' markets throughout the region.

TRFW provided many marketing opportunities for local farmers, both in person and online. At its annual Fill Your Pantry event, a farmer's market for bulk staples, producers were able to move over \$8,500 of product, and consumers were educated about buying and storing bulk crops and staple goods. TRFW redesigned its website and updated its Local Food Directory, an online listing of farm and food businesses, to increase consumer access to local foods. TRFW also partnered with EcoTrust to provide an online hub focused on connecting wholesale buyers with producers in Linn, Benton and Lincoln counties.
